me and also attempted to show his influence to

frighten all of us. Whenever the required amount is

not given to him, he becomes violent and attempts

to steal household items, allegedly for the purpose

of consuming drugs.

I am very frightened due to his repeated threats

and violent actions.

legal action against the accused at the

earliest to protect me and my family.
