1. Sixteen (16) Bottle of Himalayan Gold Country Spirit (each bottle containing 600 ML) .

I, SI Sajal Roy of Bhaktinagar PS,SPC lodged a written complainant against the above noted person to the effect that today i.e. on 01.03.2021 hrs at 20.45 hrs received a source information that at Shiv Hotel ,Sevok Road ,Bhaktinagar some persons have gathered huge amount of liquor illegally inside the hotel for selling the same in the customer for their wrongful gain. This refers to Bhaktinagar PS GDE no-44 dated 01.03.21. I informed I/C Bhaktinagar about the information . Accordingly I seized the above noted articles from the Shiv Hotel after preparing proper seizure list and took signature of the witnesses. The seizure was made between 21.25 hrs to 21.45 hrs.

I therefore request you a specific case may kindly be started against the accused person namely Paritosh Singh (40) S/O Brij Kishor Singh of Gandhinagar ,W/no-43 PS-Bhaktinagar Dist-Jalpaiguri under proper section of law.
