Majumder and also cheated me, and Mr. Majumder also told that his said brother cheated so many innocent person earlier and he always intention to cheat everyone even said Mr. Majumder also trying to cheat Mr. & Mrs. Moitra but due to help of local people said Mr. Majumder cannot succeed his illegal mission.

I would like to further inform you that, on that time said Mr. Arindam Majumder and his wife came with police and on request of police personnel I alongwith my son leave the said place.

I would like to further inform you that, my husband is a patient of a brain tumor and with so many dreams I wanted to purchase one flat but due to cheating and misappropriate by the said Mr. Jyotirmoy Majumder, his brother Sri Arindam Majumder and the wife of Arindam Majumder and the wife and daughter of said Sri Jyotirmoy Majumder, our life will be ruined, so, therefore my earnest request to you to take the serious action against the said accused person and punished them according to the law otherwise they will escape from there without any intimation.
