Subject F.I.R.

Sir,

With due respect, I am producing herewith the arrested accused person namely (1) Kamal Barman (58 yrs) S/O Late Suresh Barman of Santi Para, PS-NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure :-

1. 34 (Thirty four) bottles of Himalayan Gold 60 UP Country Spirit containing 600 ML in each bottle of Rs 100/- of each bottle.
2. 02 (two) bottles of "Kingfisher" strong premium beer containing 650 ML in each bottle of Rs 130/- of each Bottle.

I beg to report that today on 12.03.21 at 18.50 hrs I received a secret source information that one Kamal Barman of Santipara is selling huge quantity of ID liquor at Ambika Nagar Bazar. Accordingly I informed the fact to O/C NJP PS and diarised the fact vide NJP PS GDE No 587 dated 12.03.21 and as per his kind direction myself along with force left for Ambika Nagar bazaar to work out the information in hand. At about 19.05 hrs we arrived at Ambika Nagar bazar and being shown and identified by the source I apprehended one person. During interrogation he disclosed his name and address as noted above. On search the above noted ID liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of the above noted ID liquor found from his possession. Accordingly, I seized the above noted ID liquor under proper seizure list and arrested the above noted accused person under proper memo of arrest and observing all the formalities of arrest. All the process of search, seizure and arrest made in between 19.25 hrs to 20.15 hrs on 12.03.21.

Under the above noted fact and circumstances, I pray before you that a specific case under proper section of law may kindly be started against the above noted accused person namely Kamal Barman (58 yrs) S/O Late Suresh Barman of Santi Para, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
