With due respect, I, Const. 60 Pradip Roy of Special Task Force, West-Bengal, HQ at Siliguri, Ambikanagar, IR Bn. Compound, PO: Soudangihat, PS: NJP, Dist: Jaipaiguri, PIN -735135 do hereby lodge a complaint against one (1) Akhil Biswas, Advocate of Siliguri Court, PS: Siliguri, Dist: Darjeeling (Resident of Matri Mandir Apartment, Sree Man Sarani, Babupara, PO+PS: Siliguri, Dist: Darjeeling) and 15/20 others to the effect that today on 12.03.2021 at about 11:00 hrs., a person on behalf of above noted Akhil Biswas came to STF WB Office at Siliguri and stated that he has come to deliver a letter on behalf of above noted person, who is an advocate practicing at Siliguri Court. Accordingly, I received the same and as per direction, on 12.03.2021 at 11:45 hrs., I along with Const. 115 Ajimul Hoque of STF WB HQ at Siliguri left STF office for enquiring into the matter in respect of its authenticity. On 12.03.2021 at 12:25 hrs, I went to Siliguri Court Compound and enquired about Akhil Biswas. With the help of advocates present there, I met with above noted Akhil Biswas. I introduced myself and my accompanying colleague before him and stated my purpose of meeting him. He suddenly started using abusive language against us and also used filthy language against the Police force and called his other associates around and started abusing us physically. He along with his other associates torn my clothes and punches on my head, chest and they also assaulted both of us with a stick in their hands with an intention to kill us. Somehow, we both managed to save our head and the wooden stick hit my shoulders. Soon after, some of the people around came and rescued me and my colleague from the clutches of the accused persons led by above noted Akhil Biswas. Thereafter, I along with my colleague were taken to NBMC&H for our medical treatment as both of us were having severe pain all over the body. The medical officer at emergency ward of NBMC&H, Siliguri examined medically both of us and advised for various medical tests and we have undergone those tests. Presently, both of us are taking medical treatment. The medical treatment slips are enclosed herewith.

Hence, I submit that necessary legal action may kindly be taken against the above noted Akhil Biswas and his other 15/20 associates for assaulting with an intention to kill govt. servant while discharging govt, duties and obstructing a govt servant while discharging his official duty.
