Sir,
I am producing herewith one arrested accused person namely Atin Das Gupta(Male/27) S/O Ashutosh Das Gupta of Mahakalpally, near Surya Sen Park, W/No. 10, PS-Siliguri, Dist- Darjeeling along with seized articles (1) 08(Eight) Bottles of 60 UP Country Spirit styled as PET Galaxy BOSS of 600 ml each when packed, MRP Rs. 100/- each (2) 05(Five) Bottles of 60 UP Country Spirit styled as PET Galaxy BOSS of 300 ml each (3) 08(Eight) Bottles of 60 UP Country Spirit styled as PET HIMALAYAN GOLD of 600 ml each when packed, MRP Rs. 100/- each when packed, MRP Rs. 100/- each(4) 01 (One) Nylon Bag which used for carrying the seized articles Sl. N. 1 & 2.

I, ASI Khela Murmu of Panitanki TOP under Siliguri PS hereby lodge a written complaint against the above noted accused person to the effect that on 12/03/2021 at 21.15 hrs received secret source information that one person is carrying huge quantity of bottle country spirit through Raja Ram Mohan Roy Road, near Hotel Bidhan Vally, towards Mahakalpally, Siliguri. Accordingly informed to O.C Panitanki TOP and diarized the matter at Panitanki TOP vide Panitanki TOP GDE No. 311 dated 12.03.21 and thereafter as per his direction I along with ASI Surajit Mallick, C/984 Subhasish Das, CV-1009 Monoj Thakur left from Panitanki TOP vide Panitanki TOP GDE No. 312 Dt- 12.03.21 at 21.25 hrs to work out the information. On arrival at Raja Ram Mohan Roy Road, near Hotel Bidhan Vally Siliguri at 21.45 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. I intercepted the said accused person with loaded articles in presence of disinterested witnesses. During interrogation the accused failed to produce any documents/license in support of the same and stated that he will sale the same to the local public of Mahakalpally, Siliguri adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized (1) 08(Eight) Bottles of 60 UP Country Spirit styled as PET Galaxy BOSS of 600 ml each when packed, MRP Rs. 100/- each (2) 05(Five) Bottles of 60 UP Country Spirit styled as PET Galaxy BOSS of 300 ml each (3) 08(Eight) Bottles of 60 UP Country Spirit styled as PET HIMALAYAN GOLD of 600 ml each when packed, MRP Rs. 100/- each when packed, MRP Rs. 100/- each(4) 01 (One) Nylon Bag which used for carrying the seized articles Sl. N. 1 & 2 under proper seizure list and labeled the same in presence of witnesses and duly signed by them and also by the accused person. The seizure was made between 22.05 hrs to 22.35 hrs. I then arrested the accused person u/s 41 Cr.P.C. after explaining charge against him. Total value of seized articles is Rs 1850/-

Hence, under the above noted circumstances I am submitting this written complaint against the above accused person namely Atin Das Gupta(Male/27) S/O- Ashutosh Das Gupta of Mahakalpally, near Surya Sen Park, W/No. 10, PS-Siliguri, Dist- Darjeeling for starting a specific case under proper section of Law and to arrange for its investigation.
