Sir,

In producing herewith one accused person namely Akhilesh Kumar (38) S/O Lt Ram Raja Chowdhury of new professor colony, near Mamta Hotel, Ward no-16 PS+Dist- Begusarai, Bihar, along with the following seized articles as per proper seizure list:

1. Three paper made cartoons in one plastic sack, each cartoon containing twelve (12) bottle, total $12 \times 03 = 36$ bottles of Blue Mountain premium grain whisky (each bottle containing 750 ML).
2. One paper made cartoon in which contain Six (06) Pcs Bottle of Old Gold Indian Single Malt Whisky (each bottle containing 750 ML).
3. Two (02) paper made cartoon in one plastic sack, each cartoon containing twelve bottle, Total $12 \times 2 = 24$ bottles of AC Black distilled, blended and bottled in India whisky (each bottle containing 750 ML).
4. Six paper made cartoons in one plastic sack, in which contain total Seventy (70) Pcs Bottle of Royal Stag deluxe whisky (each bottle containing 750 ML).
5. One paper made carton which contain twelve (12) Pcs Bottle of Blenders pride rare premium whisky (each bottle containing 750 ML).

I, SI Sajal Roy of Bhaktinagar Police Station, Siliguri Police Commissionerate do hereby submit this written complaint against the above noted accused person to the effect that, on 15.03.2021 at 19.07 hrs, I received a specific reliable source information that, one person will come at Salugara with huge quantity of illegal liquor for disposing the same for his wrongful gain. This refers to Bhaktinagar PS GDE no- 816 dated 15.03.21. I informed to I/C Bhaktinagar about the information. As per his kind instruction I along with, SI Kamal Sarkar, C/ 762 Majibur Rahaman, C/374 Debraj Biswas and CVF/619 Dharmendra Roy, CVF/614 Sumit Kr Roy as proceed to Salugara to work out the information. Being accompanied by source our whole police party started keeping watch over people in and around in front of Honda impression Showroom, Salugara, Sevak Road and also the passengers of different vehicles. At around 21.05 hrs amidst many people one suspect person was seen and the source identified him. I alerted all my officers and force at the spot and apprehended the above noted person and on being asked he disclosed his name & identity as noted above and recovered the above noted articles from the possession of above noted accused person namely Akhilesh Kumar (38) S/O Lt Ram Raja Chowdhury of new professor colony, near Mamta Hotel, Ward no-16 PS+Dist- Begusarai, Bihar. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he procured for the purpose of dispose the same at Siliguri area and sell the same in the customer since long for his wrongful gain and also stated that he procured the same from Sikkim state and sometime before he deboarded with this articles from one Bus which came from Sikkim State. Accordingly in presence of witnesses namely 1) Sanjay Nimbu (35) S/O Lt Dutta Bahadur Nimbu of Shibnagar, Dabgram no-01, near Rema Public school PS - Bhaktinagar Dist-Jalpaiguri I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 21.15 hrs to 22.05 hrs. I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you a specific case may kindly be started against the accused person namely Akhilesh Kumar (38) S/O Lt Ram Raja Chowdhury of new professor colony, near Mamta Hotel, Ward no-16 PS+Dist- Begusarai, Bihar under proper section of law.
