With due respect, I, Sri Kartik Roy, aged 72 yrs,
S/o Late Jotindra Nath Roy, Resident of Dhakni Kata,
Champakbari, P.S: Phadhan Nagar, Siliguri, Darjeeling.
beg to state, that my son, Sri Haradhan Roy aged 34 yrs.
for the last 10 yrs, he is torturing me and my wife
Smt Jayanti Roy aged 60 yrs, and doing Physical
assault, abusued in filthy languages, every day and
night. He always made us severe injury with Iron Rod
and knife.

On 8th March 2021, at about 12.30 a.m, my son
Haradhan Roy attacked on us with Iron Rod and knife
injuring both of us, me and my wife. Did physical
assault, beat us un-humanely, due to which we
both have severely injured.

Cuts on my Nose and face, and head injured.
My wife has got similar injuries on her
face, Eyes, nose and Fore Head. Lot of
blood sheds fall from our body parts.

We immediately by the help of our neighbours
rushed to the Siliguri District Hospital for
Treatment (Doctor's prescriptions of both of us
attached for your perusal)
