I, Smt Bihani Oraon wife of late Etwa Oraon resident of Debidanga, Kalkut, Champasari, Police Station Pradhannagar, District Darjeeling, do hereby bring into your notice that I along with other legal heirs of Shani Oraon since deceased executed a power of attorney to and in favour of Prasenjit Ghosh @ Chottu son of Swapan Ghosh resident of Debidanga, Near-Bharatgas Godwoan, Police Station-Pradhanagar, District-Darjeeling, to look after and manage our properties an area 4.14 Acres, appertaining to L.R. Plot Nos. 277, 278, 281, 255, 268 & 270, recorded in L.R. Khatian No. 94, Mouza Kalabari, J.L. No. 45, under Police Station Pradhan Nagar, District Darjeeling. Prasenjit Ghosh in the year 2016 when we gave him power of attorney took Rs. 5000/- from me to procure Death Certificate of my father-in-law Shani Oraon and procure Death Certificate of my father-in-law which I have submitted as and when required before the concerned court and investigating agency i.e Pradhannagar Police Station Case No. 140/2019 pending before the D.D Siliguri, for its investigation. Taking the advantage of our Power of Attorney Prasenjit Ghosh took amount from several people without our knowledge depriving from our rights, he has transfer 3 katha of land to one Nipple Saha @ 1.5 lacs per katha, 4 katha to one Yunus Mia @ Roy @ 1.80 lacs per katha and 2 katha to one whose identity is not known to us and thereby receive huge amount out of which only 21000/- (Twenty one Thousand) only cash has been paid to us (16000/- to my son Sunil Oraon and Rs. 5000/- to me), hence we revoke/cancel the power of attorney on 04/11/2020 and lodged a complaint against the accused being Pradhannagar Police Station 791/20 dated 14/12/2020 u/s 406/420/506 IPC wherein the accused Prasenjit Ghosh @ Chottu with the help of Jhonny Kujur son of Sushil Kujur, Mangru Oraon, Bijay Oraon, Ajit Oraon, Baitu Oraon and others who by hatching up a criminal conspiracy in connivance with each other cheating by personation allegedly complied a notice u/s 41(A) of Cr.p.c and submitted forged notice u/s 41 (A) of Cr.P.C which could be easily gathered from the documents, i.e Signature in notice, application/s and bail bond are not the same, submitted by the accused Prasenjit Ghosh @ Chottu in connection with Pradhannagar Police Station 791/20 dated 14/12/2020 u/s 406/420/506 IPC. It is pertinent to mention here that as we cancel the power of attorney Prasenjit Ghosh. The accused persons Prasenjit Ghosh @ Chottu, Jhonny Kujur, Mangru Oraon, Bijay Oraon, Ajit Oraon, Baitu Oraon and others further hatch up a criminal conspiracy and portrayed one Mangru Oraon alleged to be son of my father-in-law, who has filed a Civil Case being Title Suit No. 07/2021 pending before the Ld. Civil Judge Junior Division at Siliguri, wherein I along with my son duly appeared and filed written statement and written objection along with documents i.e Death Certificate/s, Legal heirs certificate,

Khatian and complaint/s and after receiving the same Bijay Oraon under the leadership of Prasenjit Ghosh @ Chottu and Jhonny Kujur obtained a RTI which speaks that the death certificate of my father-in-law was not issued by the concerned authority. I further states when the matter was investigating by the DD Siliguri the investigating agency seeks SC Certificate which my son Rajib Oraon obtain from concerned department Shivmandir, Matigara being No. WB0104ST202001019 has also been illegally retained by Prasenjit Ghosh in order to defeat our claim. It is right place to mention here that Prasenjit Ghosh @ Chottu is in habit of making false documents. Now a days he is running a vehicle using a false number plate i.e WB 74AP 8968 whereas the alleged vehicle is originally registered at Assam. Accused persons have also procured some agreement allegedly in between Rajib Oraon and Gita Sharma wherein the alleged signature of my son Rajib Oraon and Gita Sharma's signature/s is/are not their signature as told by them.

Please do the needful and obliged me by taking necessary legal action against culprits.
