Subject : First Information Report

Sir,

I, Sri Santu Das, Son of Sri Pati Das, resident of Atul Prasad Sarani, Sukanta Nagar, Ward No. 38 of SMC, P.S. Bhaktinagar, Dist. Jalpaiguri, would like to draw your kind attention to the effect that on 15-03-2021 at around 10.00 PM when I along with one of my friend namely Gopal Saha, Son of Bishnu Saha of South Santinagar, Binay More, 2 No. Dabgram were visited at a small shop at south Santinagar, Binay More Pipeline for our own necessary requirement then one Pradip Banik, Son of Yadav Banik of Madhya Shantinagar, Korunamayee Kali Temple Road, P.S. Bhaktinagar, District Jalpaiguri came and without any reference and most intentionally started to address filthy languages indicating BJP Party and also used filthy languages addressing to our Nation's Hon'ble Prime Minister and Hon'ble Union Home Minister. When we opposed his said illegal acts and activities, he started physical assault by kicks, fist and blows upon my said friend and out of the said attack my said friend got several serious bodily injuries. He snatched more or less Rs. 3,000/- only from my said friend Sri Gopal Saha. On my present as well as at present of the local residents we somehow resisted said Pradip Banki and said Pradip Banik left the place with a threatening that if we continue to support BJP, then he would kill me and my said friend by any means.. The above person attacked us with preplanned manner and it is to be mentioned that the said person is the local influential TMC personnel. So I along with my said friend being the BJP supporters are living under the panic and mental agony of harm to our life and limb.

So it would be kind enough, if you treat this present complaint as First Information Report and take immediate drastic action/s against the above culprits along with their men and agents by imposing strict penal as well as other provision/s for the proper administration of Justice.
