Sir,

I, SI Samik Paul of Pradhannagar P.S., Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing two (02) accused persons namely 1) Jay Bhan Singh (26), S/O- Lt Godhan Singh of Porsha, PO & P.S.- Porsha, Dist- Morana, Madhya Pradesh, 2) Chhotu Singh (24), S/O- Shiv Singh of Salampur Nobel Singh, PO- Kakhatu, P.S.- Oria, Dist- Oria, Uttar Pradesh along with i) Ashok Leyland Truck having Reg. No. RJ11-GB-0080, ii) One D/L of Jay Bhan Singh having D/L NO MP06R-2020-0173204, iii) 52 Cartoons Officers Choice Blue whisky, each cartoon contains 12 bottles X 750 ml, iv) 146 Cartoons Officers Choice Blue whisky, each cartoon contains 24 bottles X 375 ml, v) 299 Cartoons Officers Choice Blue whisky, each cartoon contains 48 bottles X 180 ml, vi) 8 Cartoons McDowells No1 Deluxe whisky, each cartoon contains 24 bottles X 375 ml, which has been seized under proper seizure list (enclosed herewith), to the effect that on 15.03.2021 at 15.55 hrs I received a secret source information that one Ashok Leyland Truck having Reg. No. RJ11-GB-0080 loaded with huge quantity of illegal liquors moving from Bhaktinagar towards Champasari. Accordingly I informed the matter to the I/C Pradhan nagar P.S., SPC and as per his kind direction myself along with ASI Debasish Das, ASI Ashit Singha, CV-128 Ajay Kumar Sahani, CV-131 Ranjan Sharma, CV-223 Swapan Chettri all of Pradhan nagar P.S. took departure to verify the veracity of the source information vide Pradhan nagar P.S. GDE No 989, Dated 15.03.2021. On reaching at State Guest House more at 16.10 hrs I found that the Truck having Reg. No. RJ11-GB-0080 is coming from Bhaktinagar side. I accordingly stopped the said Truck and apprehended the accused persons namely 1) Jay Bhan Singh (26), 2) Chhotu Singh (24). On search the said truck I found that the truck seems full with cattle feed. After emigrate few of the said cattle feeds I found the truck is full of liquor cartoons under the cattle feeds. On search and count of the same I recovered the aforesaid liquors from the said Truck. On demand the apprehended persons were failed to produce any document in respect of the said liquors. I accordingly seized the i) Ashok Leyland Truck having Reg. No. RJ11-GB-0080, ii) One D/L of Jay Bhan Singh having D/L NO MP06R-2020-0173204, iii) 52 Cartoons Officers Choice Blue whisky, each cartoon contains 12 bottles X 750 ml, iv) 146 Cartoons Officers Choice Blue whisky, each cartoon contains 24 bottles X 375 ml, v) 299 Cartoons Officers Choice Blue whisky, each cartoon contains 48 bottles X 180 ml, vi) 8 Cartoons McDowells No1 Deluxe whisky, each cartoon contains 24 bottles X 375 ml., under proper seizure list in presence of witnesses, duly signed by them. Consequently I arrested the said accused persons namely 1) Jay Bhan Singh (26), S/O- Lt Godhan Singh of Porsha, PO & P.S.- Porsha, Dist- Morana, Madhya Pradesh, 2) Chhotu Singh (24), S/O- Shiv Singh of Salampur Nobel Singh, PO- Kakhatu, P.S.- Oria, Dist- Oria, Uttar Pradesh, under proper memo of arrest and intimating the ground of arrest. At 20.15 hrs the arrested accused person along with seized Truck along with liquors has taken to Pradhan nagar P.S.


