Respected Sir,

With due respected and humble submission I, Pradip Chettri Son of Late Nar Bahadur Chettri resident of Kotwali Bazar, Post Office Jalapahar, Police Station and District Darjeeling would like to inform you that my sister Miss Meena Chettri Daughter of Late Nar Bahadur Chettri is the recorded owner of a piece or parcel of land measuring 10 Kattahs in Mouza Panchanio, J.L. No. 27, in Plot No. 406 vide Deed of Sale being No. 172 for the year 2000 in the Office of District Sub-Registrar Darjeeling and mutated the said property in the office of B.L & L.R.O. Matigara and one Khatian was opened in her name vide Khatian No. 180 and after that she built one storied house in the said land which is under lock and key as she works in Japan and still now is in Japan.

That from some source information I came to know that some illegal miscreants are trying to sell my sisters property in her absence as some of the local residents informed me that the property is already sold when I enquire the matter with sister she denied that she have never sold the property and said me to look after it as I am only present in Darjeeling and I am only one who is near to look after the said property. To my anxiety I went to the Office of ADSR Bagdogra and enquired the matter where I came to know that property is already been sold one fake MEENA CHETTRI who have forged the voters identity card and sold the said land to said Munna Pradhan vide Deed of Sale being No. 113/2017. These all facts are well known by the witness of the deed of Sale being No. 113/2017 as he have identified the fake Meena Chettri as the owner of the said land as described in the Deed which is actually I saw few people and when I enquired the matter they said the Munna Pradhan is trying to sell this property and when I said that it is my sister property she escaped the scene.

Therefore Sir, kindly take this written complaint against the above named accused along with in Meena Cherttri whose photo is attached in the Deed of Sale being No. 113/2017 who is the mastermind of the said racket of forging the identity of my sister through fake voters identity card and selling her property in order and make illegal gain with criminal mind and also for criminal conspiracy for selling my sister property in fake documents.

That it is my humble request to kindly investigate in this matter as soon as possible as there is increasing racket of land mafias in Siliguri by selling others property by forging the documents and manipulating the government officers such as ADSR Bagdogra and BLLRO Matigara which is a very grievous crime which needs to be taken strict action in the due course of law.
