I, SI Pintu Ghosh of NJP PS, Siliguri Police Commissionerate producing herewith arrested accused named Biswanath Chakraborty (30) s/o Gopal Chakraborty of Baribhasha, PS NJP, Dist. Jalpaiguri with seized one Country made improvised 7.65 Pistol measuring length about 7.and ½ " fitted with but, barrel, trigger and fire pin with magazine loaded with 01 round of 7.65 mm live ammunition and do hereby lodged a complaint against accused Biswanath Chakraborty (30) s/o Gopal Chakraborty of Baribhasha, PS NJP, Dist. Jalpaiguri to the effect that today on 19.03.2021 hrs I have received a source information that one person is moving suspiciously at Thakur Nagar, Ramthakur Mandir, near Thakur Nagar Rail gate with fire Arms. On received the Information I apprised the matter to OC NJP PS and diarized the fact in General Diary vide NJP PS GDE no 992 dated 19.03.2021. As per direction of OC NJP PS, I SI Pintu Ghosh along with ASI Khagen Barman of NJP PS along with C/ 949 B. Mandal, HG-1125 J.Roy, VP/13 Jamirul Islam, VP/08 Laxman Roy, CV/306 Biswajit Roy CV/123 Ratul Bhattacharjee all NJP PS, SPC left for Thakur Nagar. On way we call two independent witnesses namely 1) Sukumal Sengupta S/o Lt. Subir Sengupta of Shaktigarh road no- 03, PS-NJP, Dist- Jalpaiguri 2) Babai Ghosh S/o Lt. Manthu Ghosh of Purba Dhantala, PS- NJP, Dist- Jalpaiguri and informed them the information in hand and requested to present during all process as witnesses they agreed to accompany with us. At 20.45 hrs. we reached at Thakur Nagar and as per identified by source it is found that one person is moving suspiciously in that area. On seeing the Police van said person try to flee away, but we managed to apprehended him. Then we give our identity as Police, initially he patent him as innocent. Finally on interrogation he disclosed his name and address as noted above. I informed him the information in hand and on searched I recovered one improvised 7.65 Pistol fitted with magazine and loaded with 01 round of 7.65 mm live ammunition, measuring approx 7 ½ " in length from butt to barrel having trigger, striking hammer and striking pin in working condition loaded with 01 round live ammunition marked as KF 7.65 from the possession of accused which he was carrying in his waist concealed underneath the shirt. On being demand, he failed to produce any valid documents in favour of said firearms and ammunition. According I seized the same under a proper seizer list in presence of witnesses namely 1) Sukumal Sengupta S/o Lt. Subir Sengupta of Shaktigarh road no- 03, PS- NJP, Dist- Jalpaiguri 2) Babai Ghosh S/o Lt. Manthu Ghosh of Purba Dhantala, PS- NJP, Dist- Jalpaiguri duly sigh by them and took into custody as Alamat of the case also I labeled seized articles properly. On further interrogation he made incoherent statements. Hence I arrested him u/s 41CrPC as he violated the provision of Arms Act. There is sufficient reason to believe that the accused person noted above was remaining there with an ulcerous motive to commit any cog offence. Search seizure label and arrest made between from 21.1 5 hrs to 21.55 hrs

So, I pray that a specific case has been initiated against the above noted arrested accused person noted above and arrange for its investigation.
