his evening walk inside his complex stating that he
is being abused and threatened by Dipin Bihari
Gupta a resident of Akshaytore Complex of
Block XIV, ground floor.

On hearing my husband's distress call
I contacted Mr. Gupta on why he was so
abusive. In a fit of rage Mr. Dipin Gupta
physically assaulted me by punching me on my
face ^{chest & head} and was witnessed by my husband, my
driver and Mrs. Sarika Jain another resident
of Akshaytore who came to my rescue. If
he was not stopped he could have molested me
as could have outraged the modesty of my
womanhood.

I appeal to you to kindly do whatever
is necessary in order to save guard
the security of women in particular and
my family in general within Akshayana Complex.

Today it was me but it can be anyone
of the body resident of the complex in the
future.

Community.
