With due respect, I, Sri Mohar Sah, Son of Sri Pati Sah, residing at Dry Fish Market, Matigara, P.O. & P.S. Matigara, Dist. Darjeeling-734010 (W.B.), beg to state as follows:-

That I along with my brother Sri Sohan Sah purchased a piece of land measuring 3 Kathas or 0.05 acres from Shieu Kishor Prasad by virtue of a registered deed of sale being No. 2578 for year of 2013 which was executed on 07.05.1997 and the said deed was presented for registration in the office of the Additional District Sub-Registrar at Siliguri-I and registration of the said deed was completed on 26.07.2013 and said deed is recorded in Book No. 1, CD Volume No. 28, Page No. 2154 to 2166 and at the time of execution of the said deed i.e. on 07.05.1997, the possession of the said land was delivered to and in favour of me and my brother Sohan Sah.

That after purchasing the said land by me and my brother Sohan Sah, have made a godown on the portion of the front side i.e. eastern side of the said land and on the back side of the said godown, some portion of the land measuring about 1 Katha is vacant and I have also been paying Panchayat tax to the Matigara-II Gram Panchayat in respect of the said land.
