Sub: First Information Report

Dear Sir/Madam,

With due respect, I would like to lay following few lines for favour of your kind consideration and necessary action:-

That I am the legally married wife of Sri Amit Das, son of Sri Ashoke Kumar Das, resident of Narmada Bagan, Champasari, P.S. Pradhan Nagar, District Darjeeling and our marriage was solemnized as per Hindu Rites and Customs at my parental house situated at 1 no. Panchanan Colony, Siliguri Junction, Siliguri on 11th day of March, 2020.

That during my marriage my parents gave Rs.70,000/- (Rupees seventy thousand) only in cash, gold chain & gold ring and watch valued Rs.3,000/- to my husband Sri Amit Das, Samsung Tele Vision, Almirah made of ply board, wooden bed, fan, table, gold and silver ornaments for me as per demand of my husband and my In-laws. My relatives also gifted many articles to me at the time of marriage.

That my parents expended more than Rs.7,00,000/- (Rupees seven lacs) in my marriage after taking financial assistance from many persons just to satisfy my In-laws.

That all the above mentioned articles i.e. dowry were taken to my matrimonial home at the time of my marriage but my husband, his parents and sisters did not become happy and started to show their real face just from the next day of my marriage and started to torture me both physically and mentally. My husband Amit Das, his Mother Smt. Anu Das, his Father Ashoke Kumar Das, his sisters namely Piyali Bauri, wife of Sri Tapash Bauri resident of Bishnupur, District Bakura and Tumpa Modak, wife of Ashim Modak, resident of Ganesh Ghosh Colony, P.O. Champasari used to beat me with blows, kicks and sticks whenever they desired.
