With due respect, I beg to report that I, SI Debabrata Khan of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge a written complaint against the owner of "Angel Bar " and others which is situated at Satyam Plaza, Sevoke Road, under Bhaktinagar PS, Dist: Jalpaiguri to the effect that on 20.03.2021 at about at 00.05 hrs while I along with force were performing night mobile patrolling duty at PS area, I received an information from duty officer that a bar styled as" Angel Bar" is still open and customer and lady singer are dancing inside and outside Bar in public place by using the full sound and they are showing discene act inside the Bar and outside the Bar as result local people are annoyed with the owner of the Bar, this refers to Bhaktingar PS GDE No 1115. dated 20.03.2021 and as per direction of I/C thaktingar PS, SPC, I along with force had been to "Angel Bar" at Satyam Plaza, Sevoke Road, on 20.03.2021 at about 00.18 hrs I reached at "Angel Bar" and I found that the "Angel Bar" was open and the singers and customer were dancing inside and outside the "Angel Bar" and they were showing obscene dance and songs with full sound resulting annoyance of local public due to their act there are likely to beach of peace or disturb the public tranquility at that area. As per govt. rule and regulation the permissible time of singing performance inside the Bar is 23.30 hrs, but the owner of "Angel Bar" violated the rule of 239 of West Bengal Excise (Foreign Liquor) Rules 1998. Further I requested to Bar manager to stop the dance performance and close the Bar but the manager of said Bar did not pay any heed but somehow I along with force manage to close the dancing and Bar to avoid any untoward incident. While performing the Government duty the owner of "Angel Bar" and others did not obeyed the lawful order promulgated by the
