lived but suddenly they started hitting me by iron rod and hit by fist and blows they further used filthy language to me and accordingly I tried to run away from there but they pulled me out from the bike and I got down and lied on the ground and again they started hitting me by their legs and iron rod and consequently I sustained injuries on my head and body parts. Furthermore they snatched my silver chain from my neck and they also took my documents from my wallet like pan card and other documents. Therefore, I somehow stood up from the ground and started to my bike and ran away or escaped my self and I directly went to Siliguri District Hospital as I sustained injuries on my head and body. Above named person have intentionally tried to kill me.
