With due respect I the undersigned would like to inform you that Sri Balal Das, S/o. Late Gobinda Das, resident of Indrani Savitri Road, Sastri Nagar, Near Bal Krishna Sangha, Ward No. 41 of S.M.C., P.O. - Sevoke Road, P.S. - Bhaktinagar, Dist. - Jalpaiguri, Pin- 734001 had entered into the marriage with me in the year of 1988 according to Hindu Rites and Customs. After the said marriage I was brought by my husband in my matrimonial house as stated above and I along with my husband had / have started to reside there as husband and wife and due to the said wedlock, I gave birth of a female child namely Mampi Das and subsequently a male child namely Bikky Das at present they are aged about 31 years and 26 years respectively. Since the date of the said marriage my husband used to misbehave with me just without any reasonable cause and on several occasions he used to return in the house almost every day at late night with plenty of liquor and whenever I tried to convince my husband to stop to have said consumption of liquor, he used to assault me mercilessly. I am being a responsible wife and mother having two children used to swallow all the pain for the future of the said children and with a hope for better conjugal life and for that I didn't take any legal step against my husband and said in-laws.
