We, the undersigned like to inform your good office that the Hon'ble State Consumer Disputes Redressal Commission, Siliguri Circuit Bench has passed an order of injunction against Luxmi Township & Holdings Limited, and its agents and restrained the said company and its agents from changing the nature and character of the land meant for construction of Community Centre in West Side of Central Park, Area meant for construction of Shopping Complex/Commercial development in east side of Central Park/Water Park and also the entire green areas including the area used and enjoyed by the complainants and other inhabitants as central park/water park/football/cricket play ground and gold play ground etc., till the next order in CC No. 22 of 2019 and that the said Hon'ble Commission has also further been pleased to pass an order on 06.01.2021 and intimated the Siliguri Police Commissioner vide its order dated : 06.01.2021 to uphold and protect the spirit of the order of the Commission passed on 04.06.2019 in proper manner. The said order was again followed in an another order dated: 08.02.2021 passed by the Hon'ble Commission.
