I SI Rana Brahma S/O LI Jitendra Nath Brahma of Panitanki TOP under Siliguri PS /SPC beg to report that on 19/03/21 at 23:40 hrs myself along with SI Prabhash, ASI Khela Murmu, C/702 Latifur Rahaman, C/984 Subhasish Das all of Panitanki TOP went to visit the Bar styled as Spice Garden situated at Bidhan Road, near Gosto Pal statue, PS Siliguri, Darjeeling for safety and security measure. This refers Panitanki TOP G.D.E No-565 Dated 19/03/21. At about 23:50 hrs myself along with above noted Police team reached at above noted Bar styled as Spice Garden and visited the above noted Bar. During my visit the following points came to my notice that:-

- (i) 06(Six) young girls were dancing there showing ugly gesture and posture towards visitors of said Bar.
- (ii) Some visitors/guest were also present on the dancing stage.
- (iii) The clothes of lady dancer were exposing their bodies and also tight provocative
- (iv) The visitors showering money towards the lady dancer.
- (v) There is no metal detectors was installed at the entrance of the Bar premises to prevent entry of any persons with arms and ammunitions
- (vi) No trained security guards were present there in the said Bar premises.

The proprietor of said Bar styled as Spice Garden has violated the Govt. Order and the conditions laid down in the license given to him by WB Excise Department vide no- 04/2016/0002

Hence, necessary legal action may kindly be taken against the proprietor of said Bar styled as Spice Garden after proper enquiry as he violated the Govt order and the conditions laid down in the license given to him by WB Excise Department.
