Olice Commi I, Sri Pravin Ray, S/O Sri Ramdeni Ray, resident of Ho-Chi-Min Nagar, Upper Sir. Bagdogra, P.O. & P.S. Bagdogra, Dist. Darjeeling, (W.B) - do hereby lodged this written complaint to the effect that on 20.03.2021 at about 8.00 AM in the morning when I was going to my office at 80 COY ASC, Bengdubi at that time suddenly my neighbour Rashida Khatoon, W/O Md. Hassim Sah of Ho-Chi-Min Nagar, Bagdogra, came out of her house and started abusing me in filthy and offensive languages over the issue of one water pipe which was lying broken near the public water tap, who also alleges that said govt. water pipe was damaged by my vehicle. Soon after one Md. Aftab, S/O Md. Hassim Sah, and two ladies namely Afsana Khatoon, D/O Md. Hassim Sah and Nurja Khatoon, D/O Late Md. Makbul Sah, who is the resident of Halal Busty, Kestopur, also joined said Rashida Khatoon and they all started assaulting me with iron rods which they brought alongwith them in their hands. As a result of which I sustained several bleeding injuries on my person, especially on my forehead from where blood was oozing out of my injured forehead. In that event said Rashida Khatoon had stolen away my gold chain weighing 10 gms from my neck and said Afsana Khatoon had taken out my money bag from the pocket of my pant which contains cash of Rs. 3000/- alongwith some bills and receipts.

Thereafter I was taken to the Bagdogra PHC by one of my friend for treatment where I was treated medically by the Doctor.

It is to be mention here that the above named culprits have also threatened me with dire consequences if the report the matter to Police or any other authority.

I, therefore, request you to take immediate legal action against the above named culprits namely 1) Rashida Khatoon, 2) Md. Aftab, 3) Afsana Khatoon and 4) Nurja Khatoon, considering the circumstances stated in above.
