## Dear Sir,

I, Sri Pitambarlal Agarwala, Son of Late Prayag Sankar Agarwala, resident of 155/2, Patel Road, Pradhan Nagar, Post Office &Police Station - Pradhan Nagar, District - Darjeeling, would like to inform you that I along with my brother Sri Atmabiswas Agarwala, are the owners in possession of all that piece and parcel of land measuring 0.48 Decimal, appertaining to and forming part of R.S. Plot No. 174, comprised in L.R. Plot No.135, recorded in R.S. Khatian No.9, corresponding to L.R. Khatian No.235, situated within Mouza -Barogharia, Pargana - Patharghata, Touzi No. 91, Police Station -Matigara, District - Darjeeling, by virtue of two Deed of Sale being no.5747 and 5746 for the year 1979. Thereafter on 14.01.1999 we received a notice for acquisition from the Land Acquisition Officer, District Darjeeling under the Land Acquisition Act, 1948, and we were directed to appear on 10.02.1999 to put up claim or objections, if any, to the measurements made under the aforesaid act to be acquired by the Government. Thereafter out of the 48 decimal of land the Government acquired 33 decimal of land as such after such acquisition we are in possession of 15 decimals of the said land appertaining to and forming part of R.S. Plot No. 174, comprised in L.R. Plot No.135, recorded in R.S. Khatian No.9, corresponding to L.R. Khatian No.235, situated within Mouza - Barogharia, Pargana -Patharghata, Touzi No. 91, Police Station -Matigara, District -Darjeeling. On 24.01.2001 we were awarded a compensation for a Page 1 of 3

total amount of Rs.53,923/- (Rupees Fifty Three thousand Nine hundred Twenty Three) only. It is pertinent to mention here that after the said acquisition we have neither sold any portion of land to any one from the aforesaid plot of land. Thereafter, we have constructed a boundary wall all throughout our said plot of land. Recently, on 27.03.2021, one Sri Pratap Khati, son of Balram Khati, Bikram Gazmer, both resident of Pradhan Nagar, Siliguri, along with some unknown antisocial miscreants most illegally and forcefully tried to take possession of our landand at that relevant point of time the locals created a hue and cry and gathered for help. Thereafter they immediately informed us about the same and upon receiving their information we immediately rushed to our plot and tried to stop the said Sri Pratap Khati, Bikram Gazmer and his men and agents. We further informed them that they have no right, title and interest over the said land and they should immediately quit and vacate the said premises but they started abusing us with vulgar languages and threatened us with dire consequences if we tried to stop them. Ultimately, with the help of the local people we could stop the intruders from succeeding in their evil motive. But before leaving, Sri Pratap Khati, Sri Bikram Gazmer and the unknown miscreants assisting them threatened us that they will come again and take forceful possession of our land by hook or by crook. They also threatened us with dire consequences if we further try to stop them in the near future. Hence, the said act is purely illegal and in utter violation of law. It is apparent from their conduct and behaviour that they are least bothered to the law of the land as such I would request you to take strict action and book the aforesaid culprits under the appropriate provisions of law so that they are not able to encroach and take forceful possession of my land.
