**SUBJECT:** FIR against my brother-in-law namely 1)SRI MANMOHAN RAJAK S/o Sri Nibu Prasad Rajak, Sister-in-Law namely 2)SMT DEEPA RAJAK W/o Manmohan Rajak and their two daughters namely 3)MISS SONI RAJAK and 4)MISS MEGHA RAJAK all resident of Shivaji Road, Khalpara, Ward No.8, Siliguri, Post Office & Police Station:- Siliguri, PIN - 734005 in the District of Darjeeling.

Sir,  
I, **SMT SIMRANJIT KAUR** W/o Sri Jagmohan Rajak, resident of Shivaji Road, Khalpara, Siliguri, Post Office & Police Station:- Siliguri, PIN - 734005 in the District of Darjeeling would like to lodge WRITTEN COMPLAINT/F.I.R against above named miscreants mentioned in the subject stating as follows:

1. That first of all I would to inform you that I reside in the ground floor of our house with my husband namely **JAGMOHAN RAJAK** and my Father-in-Law namely **SRI NIBU PRASAD RAJAK** and my mother-in-law namely **SMT SHOBHA RANI RAJAK** and my minor Son namely **MASTER SHIVAAY RAJAK** and the above-named miscreants reside in the 1<sup>st</sup> floor of our house.
2. That the above-named miscreant namely **MANMOHAN RAJAK** is a person of immoral character, having company with bad and anti-social elements of the society and has all the bad habits which a person can have and further more he has bad eye on me and have several times tried to get hold of me by touching my body improperly.
3. That Manmohan Rajak is a habitual drunkard and most often makes quarrel in our house and abuses me and my family members with bad and abusive, slang and vulgar languages which cannot be uttered in a civilised society. That my husband works in Manaberi High School and leaves from home at early morning around 7 AM and returns home at 5 PM and said **MANMOHAN RAJAK** taking the advantage of absence of my husband on several occasions he has abused me with words like prostitute, daughter of prostitute and other filthy words and have even entered my house and asked me to develop sexual relation with him and further he has threatened me that if I don't develop sexual relation with him he will do my rape. However considering the reputation of my family I never came forward to take any legal action against him.
4. That in order to extort money from my family said **MANMOHAN RAJAK** along with his wife namely **DEEPSA RAJAK** since last many month continuously stands outside the door of our house at random hours and abuses me and my family members with bad and filthy languages in a very loud voice that even all the near by neighbours can listen him abusing us and thereby disturbing the peace and tranquility of the society.
5. That said **Manmohan Rajak** has threatened me and my husband to leave our house and shift to some other place, apart from this on various occasion he has most illegally tried to take the possession of our house and over the said issue on 18.03.2021 said Manmohan Rajak along with his said wife and his above named daughters made a huge quarrel and further has assaulted my father-in-law and my mother-in-law and even gave a severe blow on the chest of my mother-in-law which caused her grievous hurt over her chest and as a result of which we took her to Siliguri District Hospital and immediately a specific written complaint was made against the said miscreants by my father-in-law before the concerned police station but till date no specific case has been initiated against said miscreant.

6. That today at around 11 AM, I was alone in my house and suddenly said Manmohan Rajak finding me alone entered inside our house and stared abusing me with bad and filthy languages however I asked him to leave my house but he finding me alone and helpless first gave me a severe blow on my chest upon which I fell down and taking advantage of the situation he gave tight kicks on private parts of my body and further he tore my clothes and made me naked and he further threatened me that if I made any complain before any police authority he will throw burning coal on my face and will burn my house too and will not hesitate to kill my husband and my in-laws.
7. That after the said incident I called my mother-in-law who immediately took me to Siliguri District Hospital for my medical treatment.
8. That in the hours of terror, I humbly request you to take necessary and immediate action and book said Manmohan Rajak and his wife Deepa Rajak and his daughters under appropriate provision of criminal law.
