In producing here with the accused person namely Bablu Das (39) yrs. S/O Late Suresh Das of Timal Para, Near Natun Sangha Club, ward No 4, P.S-Siliguri, Dist. Darjeeling, along with seized (i) 15(Fifteen) bottles of Himalaya Gold 60 up Country spirit containing 600 ML in each bottle mentioning M.R.P of Rs- 100/- in each bottle i.e. total amount of Rs-1500/- ( Fifteen hundred ) in which #1 (one) bottle taken as sample and marked as Exhibit "A-1"

I beg to report that today i.e. On 04-04-21 while performing special raid against illegal alcohol at 13.05 hrs. I received a source information that one person namely Bablu Das (39) yrs. S/O Late Suresh Das of Timal Para, Near Natun Sangha Club, ward No 4, P.S-Siliguri, Dist. Darjeeling, is selling huge alcohol at Timal Para road Side shop, Near Natun Sangha Club, Siliguri N.P.C. of the accused person, P.S-Siliguri, Dist. Darjeeling, under Siliguri, P.S. without any valid license and documents in higher price than the actual value for his illegal gain. Accordingly I informed the fact to I/C, Siliguri P.S over telephone who directed and instructed me to verify the veracity of the information. Accordingly, myself along with force left for at Timal Para, Natun Sangha club, Siliguri to verify the veracity of the information vide Khaipara TOP-GDE No -133/21 Dated: 04-04-21. After reaching at Timal Para, Near Natun Sangha Club, Siliguri, Darjeeling at 13.20 hrs and as shown by the source, I found the above noted person is selling liquor and selling secretly at Timalpara, Siliguri, to different persons and seeing the Police party the above noted person try to flee away but we managed to intercept him. On being asked he disclosed his identity as mentioned above. During search, I could recover the above noted alcohol kept in a gunny bag. During interrogation he admitted that he is selling alcohol for his wrongful gain. On demand he failed to produce any valid license or documents in support of such business. During local enquiry it has been confirmed that the above noted person is selling alcohol illegally since long. Accordingly, I seized (i) 20 (Twenty) bottles of Himalaya Gold 60 up Country spirit containing 600 ML in each bottle mentioning M.R.P of Rs- 100/- in each bottle i.e. total amount of Rs-1500/- ( Fifteen hundred ) in which #1 (one) bottle taken as sample and marked as Exhibit "A-1" the above noted accused (i) liquor under proper seizure list and labels and also arrested the above noted accused person I.C.S. 41 Cr.P.C under proper memo of arrest and observing all the formalities of arrest. The entire search and seizure process completed in between 13.25 hrs to 14.05 hrs on 04-04-21.

Under the circumstances one specific case may safely be started against the arrested accused person namely- Deb das Ray (28) yrs. S/O Late Nachu Chandra Ray of Durgi Tha colony, ward No-20, P.S-Siliguri, Dist. Darjeeling for the possessing and selling alcohol illegally and arrange for its investigation.
