Sir,

In producing herewith arrested 01 (one) accused person namely; (1) Ganesh Bin (58) S/O Late Dhamti Bin of Jyotikotola, PS- Bhore Dist- Gopalganj (Bihar) (Not verified) along with seized article viz:-

- i) One (01) plastic packet containing 970 grams said to be Ganja wrapped with plastic marked as Exhibit-A.
- ii) 100 grams said to be Ganja taken as sample from the exhibit-A and marked as Exhibits-A1.

I, SI Swadesh Saha of Siliguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against to the effect that on today (05.04.21) at 12.45 hrs on duty officer of Siliguri PS received an information from PSI Phurba Tendu Sherpa of Siliguri PS, who consisting SST team and SST Special Executive Magistrate, 26/AC, Siliguri were performing a Naka duty at Jalpaimore near Jan kalyan Pharmacy under Siliguri PS. During Naka duty the said team checked one Bus bearing no. WB-63R/0717 which was coming from Cooch Behar to Siliguri and detained one person along 01 bag containing some quantity of seems to be Ganja in presence of witnesses and the said team. This information was dirized vide Siliguri PS G.D.E no. 256 dated 05.04.21. Accordingly this information was also informed to Shri Sudip Chakraborty, I/C Siliguri PS, SPC in writing a letter to him and expressed the entire information, accordingly he directed to me to work out the information immediately, so at 13.05 hrs as per his kind direction myself along with ASI Sishen Sarkar, ASI Subir Sen, LC/1313 Mili Roy, LC/1295 Swastika Rai and CV/145 Bijay Das all of Siliguri Police Station, Siliguri Police Commissionerate left for Jalpaimore near Jan Kalyan Pharmacy to verify the veracity of the information vide M.C.C. No. 29/21 Dt. 05.04.21 which refers to GDE No.258 Dt. 05.04.21 by Govt. Vehicle No. WB 61A0137 driven by CV/285 Krishna Yadav.

At the time of departure from PS, I took envelope, white paper, sealing wax, gum, seal, Digital weighing machine (Certified by the weight and Metallurgy department) etc. At about 13.15 hrs we reached at Jalpaimore near Jan kalyan Pharmacy and meanwhile called two independent witnesses namely; (1) Mithun Barman, (29) S/O Mithu Barman of Dakshin Baro Sakdal, PS- Dinhata, PS- Seheganj, Dist- Cooch Behar (2) Goutam Basak (42) S/O Gopal Basak of Baro Ataria Bari, PS- Dinhata, Dist- Cooch Behar and disclosed our identity and informed them about the information in hand and requested them in writing to accompany us in the whole process during search, seizure and label, if any and they gave in writing about their consent to accompany Police during raid, search, seizure and label. After disclosing our identity, I found that one person was detained by PSI Phurba Tendu Sherpa and force of Siliguri PS consisting SST team and SST Special Executive Magistrate, 26/AC, Siliguri at Jalpaimore near Jan kalyan Pharmacy along with 01 no. of packet of seems to be Ganja with strong reason to believe that he is illegally carrying ganja in the said vehicle in conceal manner for supplying/ selling the same in the local area for his wrongful gain. On being asked he disclosed his identity as noted above and admitted that he possessed ganja. I then gave him option whether he wanted to be searched in presence of Executive Magistrate or any Gazetted Officer. He agreed to be searched by one of them. Further, I served him option notice in accordance with provisions of law in this regard in writing and he also gave his approval of being searched by any one in writing in the notice served to him. I also offered the independent witnesses and the accused person to search our Police Party as per provision of law. But he

refused to search the police party. Under supervision of Shri Samiran Saha, SST Special Executive Magistrate, 26/AC, Siliguri, and in presence of two independent and dis-interested public witnesses, searched the detained person following all formalities keeping his decency but nothing could be recovered on his person except wearing apparels. Then, I opened the 01 packet and found that the above seizure articles wrapped with plastic which is not visible from out side. Then all detained person confessed that he carrying these packets in conceal manner for selling/supplying in different agent at his local area. On demand in presence of Shri Samiran Saha, SST Special Executive Magistrate, 26/AC, Siliguri, he failed to produce any valid document in support of possessing of seems to be the said ganja.

I accordingly weighed the seems to be Ganja by the weighing instrument and found total 970 grams of said to be ganja in one plastic packet and marked as Exhibit-A, and also collected sample from the Exhibits A and marked as exhibits A1 respectively. Then, I seized the above noted articles under proper seizure list and label duly signed by the above noted witnesses and Shri Samiran Saha, SST Special Executive Magistrate, 26/AC, Siliguri and acknowledged by the accused person. The whole search, seizure & label was made in between 14.25 hrs and 14.55 hrs. On further asked the apprehend person confessed in presence of Shri Samiran Saha, SST Special Executive Magistrate, 26/AC, Siliguri and other witnesses that he procured the Ganja from Coch Behar for the purpose of making money. On interrogation he disclosed that he had been dealing in such business of selling the ganja illegally since long.

Then I arrested the above noted accused person after observing all guidelines of Apex court of arrest, as he violated the terms and condition of Narcotic Drugs for possessing Ganja without any valid authority & license.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely, (1) Ganesh Bir (58) S/O Late Dhimli Bir of Jyotisitola, PS- Bhore Dist- Gopalganj (Bihar) (Not verified) and arrange for its investigation.
