Subject:- FIR for serious verbal and physical assault

Respected Sir,

I, Anand Kumar Bansal son of Shri

Krishna Kumar Bansal residing in B-115 Dwarka  
Sector 8 Delhi was visiting family in Siliguri and  
temporarily residing in E-Gulmohar Apartment,

171 Road Siliguri want to submit the following FIR,

- That I was driving car number WB74AH1483 from  
Sawoke road towards Gulmohar Apartment taking the  
171 Road on 5/4/2021 around 12.30 pm.
- That while slowly overtaking a cycle rickshaw after  
sounding proper horn and taking overtaking space, the  
rickshaw puller brushed his rickshaw on the side  
of my car towards the rear side portion of the car  
and fell down.
- That I as a responsible citizen immediately stopped my  
car to assess damage to the rickshaw puller and  
to help him. The rickshaw puller appeared fine as he  
was standing and was walking. However, I still offered  
medical help in nearby hospital and suddenly few (4-5)  
people came on a scooter and bike and started  
abusing and hitting me. It seemed as if they were the  
rickshaw puller personally.

That I checked their pictures using my mobile phone -  
my brother on his phone.  
That I tried to reason with them but they appeared  
intent on hitting me. They put me on the ground  
and kicked me severely all over the body, mainly on the  
head. My Samsung A50 mobile device broken in the  
process. When I got up and tried to take the phone  
for checking, one of the people in the photo hit me  
with a danda on the head and I started bleeding.

- That my brother reached the spot and seeing him  
all of them tried to run away on their scooty but my  
brother was able to note their scooty number which is  
WB74AR9450. My brother's name is Pravin Agarwal.

- That my brother took me to Siliguri Sader Hospital  
for treatment and doctor's report is attached for  
your reference.

- That on 6/4/2021, the rikshaw puller and people  
known to him called my brother on his phone and  
demanded money.

Therefore, through this FIR, I want my brother  
seek protection and justice from you. I would  
request you to identify the culprits as per the pictures  
provided by me to you and register relevant case  
against the attackers for prosecution as per law  
and to provide me with appropriate compensation.


