Sir,

In producing here with one accused person namely Khushee @ Sukumar Sarkar (35) S/O Gurupada Sarkar of Fakdaibari Near Hatiadanga Primary School PS Bhaktinager Dist. Jalpaiguri and the following articles under seizure:

(1) 15 (Fifteen) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.100/-

I SI Pradip Kr Singha of Ashighar OP lodged a written complaint against the accused person namely Khushee @ Sukumar Sarkar (35) S/O Gurupada Sarkar of Fakdaibari Near Hatiadanga primary School PS Bhaktinager Dist. Jalpaiguri to the effect that, on 07.04.2021 evening as per order of O/C Ashighar OP I along with ASI Amit Mallick, C/ 877 Munna Ahmed and CV/616 Ananda Das all are of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashigharh OP in course of which I received information from my source that one Sukumar Sarkar stored a huge numbers of bottles of liquor inside his house at Fakdaibari Near Hatiadanga primary School, and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Fakdaibari Near Hatiadanga primary School area to verify the veracity of information. On the way I called two local person namely (1) Biplab Roy (23) S/O Dipak Roy of Fakdaibari Near Hatiadanga primary School PS Bhaktinager dist. Jalpaiguri and (2) Krishna Sarkar (20) S/O Khushi Sarkar of do to accompany us to witness the search and seizure if required. On reaching at Fakdaibari Near Hatiadanga primary School area as indicated by my source I held raid at the house of Khushee @ Sukumar Sarkar at Fakdaibari Near Hatiadanga primary School, But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his house. I seized the above noted articles as alammath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 22.45 hrs and 23.05 hrs on 07.04.2021.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons namely Khushee @ Sukumar Sarkar (35) S/O Gurupada Sarkar of Fakdaibari Near Hatiadanga primary School PS Bhaktinager Dist. Jalpaiguri and arrange for its investigation.
