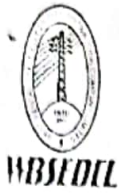

Sub: Information regarding a fatal electrical accident occurred on 06.04.2021 near Jotiakali, Radhabari area at 10.00 AM (Approx.)

Sir,

This is to inform you that on 06.04.2021 at around 12:56 P.M. from Local News Channel I came to know about an electrical accident occurred at Jiyaganj, Jotiakali, Radhabari under Jalpaiguri District. During inspection by the undersigned it was found that a double decker truck Bearing No. PB65AZ1059 was passing through NH 31D. Bus driver may have to drive reverse as such process he entered into under construction NH 31D Extension road. A helper namely Rohit age around 23 years from Haryana climbed at the top of double decker truck and instructed to the driver. Our 11 KV Fulbari feeder is passing at that location and the double decker truck came just below this 11 KV Fulbari feeder. The driver did not notice about that. It may be stated that helper (Rohit) told driver for stopping the truck but the driver did not listen his words as a result he came into contact with our 11KV Fulbari feeder emanating from Radhabari 33/11 KV Sub- station and gets electrocuted. After that incident local people admitted him to North Bengal Medical College & Hospital and declared him dead. This may be treated as F.I.R.

These all above information is for your kind perusal please takes necessary action.
