Sir,

In producing here with the accused person namely- Ajay Gupta (23) yrs. S/O-Late Mohan Gupta of Vivekananda Road, Near Kali Mandir, Opposite Red light area, Ward No-7, P.S-Silguri, Dist. Darjeeling along with seized (i) 20(Twenty) bottles of Himalaya Gold 60 up Country spirit containing 60% ML in each bottle mentioning M.R.P of Rs- 100/- in each bottle i.e. total amount of Rs-2000/- (Two thousand/-) in which 01 (one) bottle taken as sample and marked as Exhibit- "A-1".

I beg to report that today i.e. On 07-04-21 while performing special raid against illegal alcohol at 16.15 hrs. I received a source information that one person namely- Ajay Gupta (23) yrs. S/O-Late Mohan Gupta of Vivekananda Road, Near Kali Mandir, Opposite Red light area, Ward No-7, P.S-Silguri, Dist. Darjeeling is selling huge alcohol at Vivekananda Road, Khalpara, in side Gupta Hotel, Silguri, SPC. of the accused person, P.S-Silguri, Dist. Darjeeling Under Silguri P.S. without any valid license and documents in higher price than the actual value for his illegal gain. Accordingly I informed the fact to I/C. Silguri P.S over telephone who directed and instructed me to verify the veracity of the information. Accordingly, myself along with force left for, at Vivekananda Road, Khalpara, in side Gupta Hotel, Silguri, SPC. to verify the veracity of the information vide Khalpara TOP GDE No -331/21 Dated- 07-04-21. After reaching at Vivekananda Road, Khalpara, in side Gupta Hotel, Silguri, SPC. at 17.35 hrs and as shown by the source. I found the above noted person is selling liquor and selling secretly at Vivekananda Road, in side Gupta Hotel, Silguri, SPC. to different persons and seeing the Police party the above noted person try to flee away but we managed to intercept him. On being asked he disclosed his identity as mentioned above. During search I could recover the above noted alcohol kept in a gunny bag. During interrogation he admitted that he is selling alcohol for his wrongful gain. On demand he failed to produce any valid license or documents in support of such business. During local enquiry it has been confirmed that the above noted person is selling alcohol illegally since long. Accordingly, I seized (i) 20(Twenty) bottles of Himalaya Gold 60 up Country spirit containing 60% ML in each bottle mentioning M.R.P of Rs-100/- in each bottle i.e. total amount of Rs-2000/- (Two thousand/-) in which 01 (one) bottle taken as sample and marked as Exhibit- "A-1". The above noted recovered I.D. liquors under proper seizure list duly packed, sealed and labeled in presence of witnesses and took their signature in the seizure list and labels and also arrested the above noted accused person U/S- 41 Cr.P.C under proper memo of arrest and observing all the formalities of arrest. The entire search and seizure process completed in between 17.35 hrs to 18.25 hrs on 07-04-21.

Under the circumstances one specific case may kindly be started against the arrested accused person namely- Ajay Gupta (23) yrs. S/O-Late Mohan Gupta of Vivekananda Road, Near Kali Mandir, Opposite Red light area, Ward No-7, P.S-Silguri, Dist. Darjeeling for the possessing and selling alcohol illegally and arrange for its investigation.
