Sir,

In producing herewith one accused person namely Rabindar Chowdhury-20yrs s/o Lt Rambilash Chowdhury of Hookers corner, Near Shiv Mandir, ward no-18, PS Siliguri Dist Darjeeling at present C/o Pintu Banik of Ghugumali, Near Jagatbandhu Ashram, ward no-37, PS Bhaktinagar Dist Jalpaiguri along with the following seized articles as per proper seizure list:

1. 20 (Twenty) pet bottles of 'Dil Se' 80 up country spirit (each Bottle containing 600ML & MRP Rs-100/-) which was kept in one gunny bag.
2. 80 (Eighty) bottles of KINGFISHER STRONG Premium Beer (each Bottle containing 650 ML & MRP Rs-130/-) which was kept in seven cartoon.
3. 10 (Ten) bottles of officers Choice Deluxe Whisky (each Bottle containing 180 ML & MRP Rs-140/-) which was kept in one gunny bag
4. One TVS Jupiter Scooty having Registration No- WB74AX/0053

I, SI Srimanta Chatterjee of Khalpara TOP, PS Siliguri under Siliguri Police Commissionerate lodged a written complainant against the above noted person to the effect that on 14.04.21 at 10.10 hrs received an information from Vivekananda road under Siliguri PS that one person has coming on a Scooty with huge quantity of illegal liquor for selling the same in the open market for his wrongful gain. Diarized the fact in GD vide Khalpara TOP GDE No-748 dated 14.04.21. As per your kind instruction myself along with ASI Kala Chand Singha, Const/1183 Nikhil Saha and CVF/980 Ranjan Ojha proceeded to the PO to work out the information. At 10.25 hrs we reached at Vivekananda Road. Sometimes after being identified by the source our police party apprehended the above noted person with a TVS Jupiter Scooty and recovered the above noted articles from the possession of above referred person. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in open market for his wrongful gain. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and level and took signature of the accused person one bottle taken as sample. (The seizure was made in between 10.40 hrs to 11.45 hrs) I arrested the accused person u/s 41 Cr.p.c. and issued Memo of arrest appraising the ground of arrest.

I therefore request you a specific case may kindly be started against the accused person namely Rabindar Chowdhury-20yrs s/o Lt Rambilash Chowdhury of Hookers corner, Near Shiv Mandir, ward no-18, PS Siliguri Dist Darjeeling at present C/o Pintu Banik of Ghugumali, Near Jagatbandhu Ashram, ward no-37, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation.
