With reference to the above mention subject I would like to inform you that Mr. ERUKALA THARESH booked the indigo flight 6E 3013/348 from Bagdogra to CCU and to BLR with reference PNR-HGMNYI was carrying 100 live ammunition in his check in baggage and was detected at X-Ray BIS by Indigo staff. We have cross checked and found that the passenger is from armed force and not carrying any movement order/valid document. As per BCAS (BUREAU OF CIVIL AVIATION SECURITY) guideline we have not accepted the passenger along with baggage and handed over the above mentioned passenger to the local police along with 100 live ammunition for further necessary action.


