Dear Sir,

Myself Mr. Riyajul Hossain Mallick C/o, Sri Rafique Hossain Mallick residing at Ward No-40, Ashrafnagar, Masjid Road, Siliguri, Pin- 734001 has been working with Bisleri International Pvt. Ltd as Senior Sales Executive since Dec,2019.

Having been informed from a reliable source that duplicate Bisleri products are supplied in market we found yesterday a full truck( WB 73F 7058) loaded with Bisleri jars with unsealed cap nearer to the Aquamineral Beverage plant along with original GST invoice copy ( attached for your reference) in the name of Aquamineral Beverages ( Invoice No.AMB/2122/GST/018 dated 18.04.21) . It is clearly indicating that those 20lt jars are illegally procured and sold in market by Aquamineral Beverages plant.

The disputed truck driver name is Mr. Sukumr Paul and licence number of drivar is WB 7320050339437.

Plant owner of Aquamineral Beverages, Mr. Gaurav Surana also reached at Matigara Police Station and tried forcefully not to lodge any complain. Mr. Gaurav Surana also called other senior Bisleri International Pvt Ltd staffs to settle the issue outside the police station.

I would like to notify that Bisleri had stop operation there from 01.03.21 and already informed to Regional FSSAI deparment for closing of BISLERI operation there.


By considering the above mentioned scenerio, it is our earnest request to take necessary legal actions against Aquamineral Beverages for doing this illegal activities.
