Sir/Madam,

I, Smt. Ankita Ghatak, w/o Shri Santanu Roy, resident of Kishori Tower Apartment, Indirapally, Shirmandir, Kadamtala would like to inform you that today at around 10.30 am I went to the auto stand near Sri Narasingha Vidyapith, Shirmandir to get an auto to Siliguri as I work there. I took the auto numbered WB-73F-4683 which runs between Siliguri to Shirmandir. As the auto didn't start the journey even after half an hour I enquired the driver about not starting the vehicle, as a return he started misbehaving with me and threw slangs towards me. As I retorted back he came down from the driver's seat and in a threatening voice scolded at me to get down from the vehicle immediately. When I again asked about his misbehaviour he dragged me out of the vehicle and threatened me saying that he is local boy and he will take revenge later on. He didn't stop the harassment there, rather continuously used 'slangs' and tried to slap me on my face. I am in utter fear and in deep trauma to even get out my house.

Thus I sincerely request you to please take the necessary step against him and allow live fearless.
