With due respect I, Sri. Pritpal Singh Chhabra, S/o. Balwant Singh Chhabra, presently residing at Uttorayon, Block-C2, Plot No.12, "NEIL", P.S. Matigara, Dist. Darjeeling beg to state that in the month of February 2021, I have taken the aforesaid flat on rent from Mr. Jayanta Mallick and since then I along with my family members including my wife, children and father are residing thereon.

Today i.e. on 16.04.2021, at about 4:00 A.M.(early morning), when my wife Jasbir Kaur Chhabra went to bathroom, she has noticed that the window situated at the North-West side of our said rented flat is open and after noticing the same, she has closed such window and again come to master bedroom.

On the same day, at about 11:00 A.M., when my wife getting out of the bathroom and opened the almirah, after looking into it she found that my valuable things (ancestral properties) i.e. 3(three) Diamond Rings, 4(four) Gold rings, 2(two) Gold Chain, 5(five) Pair ear rings worth Rs.8,00,000/-(approx) and cash of Rs.4,00,000/-(Four Lacs) which were lying in the said Almirah are missing from said Almirah. Thereafter, I have tried my level best to enquire the matter and I came to learn from my neighbour Doctor Bhowmick who is residing in Block-C3 within the same plot that some persons have also attempted to theft in his flat also, and the face of such thieves have been captured in his CCTV Camera. I have doubt that the same thieves have taken away the above mentioned valuable things from my rented house.

Therefore, I request you to look into the matter and to take necessary legal steps for tracing out the above mentioned things / items and to take necessary action against the thief/thieves who has/have stolen my valuable properties. And for this kindness, I shall much oblige to you.
