1. That I and my wife namely Smt. Anita Saha are the joint owner of a piece or parcel of land measuring 2 Kathas being L.R. Plot No. 296(P) 303(P), J.L No. 75, Mouza : Kawakhali, P.S. Matigara, Dist. Darjeeling vide registered Deed of lease being No. I-1429 for the year 2015.

- 1) That I am an oldage helpless man after the demise of my wife, I have been living with my son. My son always used to torture mentally and physically harassed me and I was ill-treated, beaten up and assaulted me several times at various occasion without any fault on my part by my son. drunken condition and torture me physical and mentally and he abused me in filthy languages and on 31/03/2021, he threatened me with dire consequences if I fail to fulfil his demands and beaten me severally and I sustain grievous injury so I have gone to NBMC & Hospital for my treatment and he even did not maintain me in any manner, So finding no other alternative I came before your good self to request you to kindly take necessary legal steps against my son as per provisions of law.
