I, SI Sibdhan Karmakar of Bhaktinagar Police Station under Siliguri Police Commissionerate do hereby lodge a written complaint against (1) Binod Sharma (42) S/O- Mishri Prasad Sharma of Iskcon Road ,Gitalpara, Ward No-40 PS- Bhaktinagar Dist- Darjeeling Garage owner of Sahara Garage (2) Bikash Sharma S/O- Late Mahendra Sharma of Shastrinagar near Radha Krishana Complex ,Ward No-41 PS- Bhaktinagar Dist- Jalpaiguri ,(3) Gourav Sharma S/O- Mishrilal Sharma of Monpori Busty PS- Bhaktinagar Dist- Jalpaiguri and (4) Nanki Paswan S/O- Not known of Manpori Busty, Gandhinagar PS- Bhaktinagar Dist- Jalpaiguri to the effect that today on 19/04/2021 at 20:15 hrs received a specific input from source that one Binod Sharma & others kept some vehicles in their Garage name and style as "Sahara Garage "and also kept some vehicles at Mahendra Sharma Garage, some vehicles at Mishrilal Garage and some vehicles at Nanki Grage situated at Gandhinagar under Bhaktinagar Police Station which have been suspected to bring from somewhere else by stolen means or fraudulence means in order to clandestine dispose the same. Accordingly I diarized the fact in G.D. vide Bhaktinagar P.S. G.D.E. No-1646 date 19/04/2021 and share the information with I/C, Bhaktinagar Police Station and as per his kind direction myself along with ASI ,Rabin Lama , ASI Biswajit Saha CV-619 Dharmendra Roy and CV-935 Biplab Roy left for Prokash nagar, Chandal More to verify the veracity of the information . On reaching there and identified by source we firstly cordoned the Sahara Garage where found two vehicles bearing registration No- UP30T- 7400 and vehicle No- WB21AN- 3531 were parked inside the garage . Accordingly we entered in to the garage and checked both the vehicles and it seems to me that the engine no and chassis no of both the vehicles have been tempered. On being asked neither the Garage owner namely Binod Sharma produced any valid documents nor any satisfactory statement in respect of the parked vehicles mentioned above. Thereafter I Sent a requisition to mechanical expert Sri Bhola Nath Baruri , Anil Trading ,Sevoke road ,Siliguri with a request to came in the spot and examine the vehicle . After a while Sri Bhola Nath Baruri turned up in the spot and examined the above noted two vehicles and opined that the engine no and Chassis no of both the vehicles have been tempered. Hence, myself seized both the vehicles preparing memo of seizure in presence of available

witnesses and after proper satisfaction arrested Binod Sharma (42) S/O- Mishri Prasad Sharma of Iskcon Road, Gitalpara, Ward No-40 PS- Bhaktinagar Dist- Darjeeling who also confessed his guilt and stated the fact that he had brought the above mentioned both vehicles from a person of Uttar Pradesh which will be verified in course of the investigation of the noted case. Thereafter We proceeded to Mahendra Sharma body builders Garage situated at Gandhinagar to verify the further information of source along with mechanical expert Sri Bhola Nath Baruri where on searching and verification further recovered (1) WB 78- 4957, (2) UP 35T- 2446 (3) Vehicle registration No-Nil, Chassis No- MAT466428G5D26005, (4) WB76D- 0282, (5) UP78FN- 9172 (TATA Dumper) (6) Vehicle registration No-Nil, Chassis No- 388122EF2117646 (7) UP35T- 0999, (8) UP78CN- 4584, (9) WB73C- 1583, (10) WB73B- 5730 from the garage of one Bikash Sharma S/O- Late Mahendra Sharma of Shastrinagar near Radha Krishana Complex, Ward No-41 PS- Bhaktinagar Dist- Jalpaiguri but the owner could not available there. Accordingly Sri Bholanath Baruri examined the above noted vehicles and opined that the engine no and Chassis no of the vehicles have been tempered. As such I seized the above noted vehicles as per proper seizure list duly sign by the available witnesses. Thereafter we arrived at Mishrilal Garage, Monpori Busty, Gandhinagar along with Mechanical Expert Sri Bhola Nath Baruri to verify the further information given the source but the garage owner Gourav Sharma S/O- Mishrilal Sharma of Monpori Busty PS- Bhaktinagar Dist- Jalpaiguri is not available, where also recovered one vehicle bearing registration SKO2D- 0472 which is also tempered as per opinion of mechanical expert Sri Bhola Nath Baruri. Hence, I seized the vehicle as per proper seizure list duly sign by the witnesses. Thereafter I further along with officers and force and mechanical expert Sri Bhola Nath Baruri arrived at Nanki Garage at Manpori Busty, Gandhinagar to verify the information but there also Garage owner namely Nanki Paswan is not available and recovered one vehicle bearing registration No-WB73D-0502 has been parked. On hue and cry owner of the garage did not turn up. It seems to me that the Garage owner fled away after getting the information of the presence of Police party. Accordingly Sri Bhola Nath Baruri examined the vehicle thoroughly and opined that chassis no & Engine no have been tempered. As such I seized the vehicle as per proper seizure list duly sign by the witnesses.

On local enquiry it came to learn from the local people that (1) Binod Sharma (42) S/O- Mishri Prasad Sharma of Iskon Road, Gitalpara, Ward No-40 PS- Bhaktinagar Dist- Darjeeling Garage owner of Sahara Garage (2) Bikash Sharma S/O- Late Mahendra Sharma of Shastrinagar near Radha Krishana Complex, Ward No-41 PS- Bhaktinagar Dist- Jalpaiguri, (3) Gourav Sharma S/O- Mishrilal Sharma of Monpori Busty PS- Bhaktinagar Dist- Jalpaiguri and (4) Nanki Paswan S/O- Not known of Manpori Busty, Gandhinagar PS- Bhaktinagar Dist- Jalpaiguri have been dealing such kind of illegal business since long preparing forged documents in respect of the vehicles for the purpose of cheating and dishonestly dispose the vehicles to their design customers for their wrongful gain.

Therefore, I pray before your honour that a specific case may kindly be started against (1) Binod Sharma (42) S/O- Mishri Prasad Sharma of Iskon Road, Gitalpara, Ward No-40 PS- Bhaktinagar Dist- Darjeeling Garage owner of Sahara Garage (2) Bikash Sharma S/O- Late Mahendra Sharma of Shastrinagar near Radha Krishana Complex, Ward No-41 PS- Bhaktinagar Dist- Jalpaiguri, (3) Gourav Sharma S/O- Mishrilal Sharma of Monpori Busty PS- Bhaktinagar Dist- Jalpaiguri and (4) Nanki Paswan S/O- Not known of Manpori Busty, Gandhinagar PS- Bhaktinagar Dist- Jalpaiguri as per proper section of law.
