I, **MAMONI MALO**, W/O Amar Malo, D/O Gopal Das, presently resident of C/O Gopal Das, Madhya Chayan Para, Ghogomali, P.O. Rabindra Sarani, P.S. Ashigarh, Dist. Jalpaiguri, I do here by want to inform you as follows :-

1. That I lodge this F.I.R to the effect that on 27.02.2015 I was married to Sri Amar malo, S/O Late Jiten Malo, Resident of Papia Para, Bhaktinagar, Dist. Jalpaiguri.
2. That during the marriage negotiations, my husband demanded Freeze, Almirah, Dressing Table, etc including all the household articles including cash dowry of Rs. 80,000/- (Rupees Eighty Thousand Only) from my father. Moreover in this regard I would like to inform you that my husband specifically told my father that all the demanded articles along with cash dowry of Rs. 80,000/- (Rupees Eighty Thousand Only) must be given to them prior to marriage ceremony and subsequently as per the demand of my husband, my father has given all the above mentioned articles along with cash dowry of Rs. 50,000/- (Rupees Fifty Thousand Only) and gold ornaments worth Rs. 1,50,000/- (Rupees Two Lakh Only) to my husband, in presence of the other relatives.
3. That subsequently soon after marriage my husband **Amar Malo**, mother-in-law namely **Pabitri Malo**, Brother-in-law namely **Samar Malo**, Sister-in-law namely **Shipra Barman**, Husband of Shipra barman namely **Rabi Barman**, Sister in law namely **Rekha Das**, Husband of Rekha das namely **Dula! das**, Sister in law **Urmila Malo**, Husbnad of Urmila Malo namely **Raju**, started to torture me both mentally and physically and pressurized me to bring money from my father and when I refused to comply their demands my husband and

his other family members above mentioned bang my head on the wall by pouring towel into my mouth so that I cannot scream, there were several times when I used to get unconscious, my husband used to take my nude picture and when I get conscious they blackmailed me by threatening me that they will publish the said pictures if I unable to fulfill their demand. Moreover, my husband and my mother in law always used to humiliate me in all respect and in spite of fulfilling all their dowry demands my husband and my mother in law was never happy with me and always used to taunt me as I had brought insufficient dowry. I was treated like a servant from the very beginning and not given the status of a wife. I was bearing all the torture of my husband and his family members above mentioned with a hope that everything will be alright in future but everything was in vein.

4. That subsequently after few months of our marriage I got pregnant and after knowing that I am pregnant my mother in law increased torture upon me and forced me to take money from my parental house to take care of my unborn child and when I protested against their illegal demand my husband my mother in law and my sister in laws started to beat me mercilessly and they threatened me that if I don't bring money from my father and hand over to them as per their demand then they will forced me to abort my unborn child.
5. That subsequently all the above named persons locked me in the kitchen and spread Kerosene oil all over the kitchen through the window with an intension to burn me alive and when I started to scream then some neighbors came and recued me but the above mentioned persons through me out of my matrimonial house with a single cloth and I was forced to take shelter in my parental house.
6. That subsequently out of our wedlock one male child namely Abhi Malo was born on 17.01.2016. After the birth of my son I thought that everything will be alright but all are in vein as my father took me to my matrimonial home along with the infant baby and my father at that time gave another some of Rs 30,000/- (Rupees thirty Thousand) only to my husband and other in laws as par their demand.


7. That thereafter my husband started to come home in a drunken condition almost at every night and started to beat me mercilessly and my other in laws started to torture increases day by day upon me as well as upon my infant son but I tolerate all the torture with a hope that everything will be alright in future. Moreover after passing of time I revealed that my husband is in extra marital relationship with several women and my husband very frequently used to leave from the home and stayed out of the house for 3 to 4 days without informing me anything and when I tried to ask him about his absence my husband got furious and started to beat me mercilessly, also threatened me. I remained silent for the sake of my infant son but since the year 2017 everything of my life has been jeopardized by my husband and above named in laws.
8. That after knowing the fact when I started to protest the same my husband became very furious and started to keep me and my infant son in a lock and key condition in the house and not even provide sufficient food and other necessities to me and my infant son and always forced me to bring money from my father otherwise he will not allow my stay in my matrimonial house.
9. That subsequently my husband gradually took all my gold jewelry from me forcefully and sold them for the purpose of playing gamble and when I tried to protest the same my husband tried to kill me by covering my face with the pillow and also even tried to kill me by keeping the gas oven open in the kitchen.
10. That in the year of January 2019 my husband and other in laws namely **Rabi Barman, Dulal das, Raju** started to take alcohol inside the house by causing great disturbance and when I tried to protest, my husband and his other family members caught hold of my hair and forcefully hanged me. At that time some of the neighbours came and rescued me after hearing my scream. Moreover my husband used to have forceful sexual intercourse with me by putting my infant son on the fear of death.
11. That few days later at night my husband told me to go back to my parental home along with the infant child as he could not tolerate me. When I refused to do so he tried to strangle me to death. The next day I called my family members to make him understand but he refused to listen to anything and told them to take me away and threatened me with dire consequences if I dared to stay at my matrimonial house but when my family members did not take me with them, my husband tortured me throughout the day at night mentally and physically by abusing me and my family threatening to kill each one of them and if I tried to protest my husband slapped me and kicked me and hit me with fist and blows and threatened to burn me and my infant son to death if I did not go away.

12. That on 07.04.2021 my husband thrown me and my infant son away from the house and subsequently finding no other alternative I have to take shelter to my father's house along with my infant son leaving behind all my personal things, jewelries and other stridhan properties to my matrimonial house.
13. That after that my husband and his other family members, started to put pressure upon me to give divorce to my husband and when I refused to do so my husband and his family members, started to threat me that they will kidnap my infant son and sell him out to other State.
14. That at present I am living in very depressed condition and became mentally and emotionally ruined due to the above mentioned cruel acts and conducts of my husband and his other family members above named.

I therefore request before your good self to kindly look into the matter and take necessary action against **my husband and his other family members above mentioned** as per the provision of law and for this act of kindness I shall remain extremely grateful to you.
