I, Labisha Tamang Biswakarma, wife of Nimesh Biswakarma, R/o. Sukanta Nagar, Upper Bagdogra, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, in the State of West Bengal, INDIA, would like to state that I was married to Sri Nimesh Biswakarma. Out of the said marriage I gave birth to a male child aged about seven (7) years. After birth of my child my husband was changed and he used to come home late night and physically assault me for want of money. I was shocked when I saw his original face. He used slang language and insult me infront of everyone. My husband used to physically assault me unnecessarily. My husband always used to shout at me on simple issues and used to mentally & physically torture me to bring money from my old & aged parents. I tried my level best to give him everything in order to satisfy him but all went in vain. My husband suddenly left home on 12/04/2021 at about 6.30 P.M. without informing me about his whereabouts. When he didn't return home till 15/04/2021 I searched him and found him at about 9.30 P.M. at the house of one Lady Constable No. 393 namely Doni Pakhrin at Motajote, Vivekanandapally, Khaprail, behind Barsana, Matigara who is recently posted at Sukna Police Station, Sukna, Darjeeling. When I entered her room I found both of them in a very bad condition. They were in

One year before also after knowing the fact I requested my husband & Doni Pakhrin not to keep any relationship as my husband is married but they didn't pay any heed to my request. My husband signed a mutual understanding letter (Samjhouta Patra) and promised not to do any such act in future but the same thing occurred again. It is requested before you in folded hand to kindly take strict necessary action against my husband and Doni Pakhrin so that they can be punished.
