<u>Sub: FIR against violence during election on 17 Apr 2021 and continued threat to life and property.</u>

Dear Sir,

1. You are hereby informed that during voting process on 17 Apr 2021 at Chunabhati, Booth no- 19/189, West Dhantala, Satellite Township, Dist- Jalpaiguri, 734015 our BJP Party members were attacked and hurt by Md Badiur Rahaman and his goons. Md Badiul Md(Rafi), Md Rabiul Karim(Bokul Master), Biplab Singha, Md Sher Ali, Rohamat Ali, Bipul Sarkar, Md Jiyarul Rahaman, Ranjit Das, Ujjal Debnath preplanned the whole event of violence and constantly instigated a communal crowd called from Fulbari Bazar, Jotiyakali, East Dhantala and NJP. Finally the TMC goons mixed with communal mob from outside attacked BJP party members immediately after security forces left the pooling booth with EVM. They attacked with Stones, Lathi and Sharp weapons which was already kept in place and hurt number of individual causing serious damage to life and property. One member named Mithu Saha received stone blow on his leg and is bed ridden with injured leg and another aged lady was hurt badly in her hand and shoulder. Other party members named Bablu Mandal, Bashudev Baroi, Piyolal Mandal and Bimal Roy all resident of West Dhantala received stone blows in multiple places. They destroyed one motorcycle which belong to Sujit Roy, West Dhantala and snatched money (Rs 5000) and documents (voter card, aadhar card, ATM Card and other documents) from one individual named Nimai Barman, West Dhantala and threatened to murder all present there. Finally with timely arrival of Police Force and execution of Sec144 the situation came under control. This preplanned attack by above mentioned individual continued till yesterday dated 18 Apr 2021 with spread of false propaganda via media and facebook posts. They even went to the extent of falsely propagating that Md Rabiul Karim(who came from Jotiyakali) received a stone blow but in reality he was the one who was throwing stones and to control him the Police had to use force, during which this antisocial element received a lathi in his hand which he is now showing in

- media as stone injury. The situation is very volatile in Chunabhati and West Dhantala as these goons are constantly inciting communal propaganda and giving constant life threat to BJP party members and Hindus in particular.

The names of local goons along with goons called from outside who preplanned this violence and executed stone pelting, hurting man and woman grievously with intent of murder, snatching money and important government documents and destruction of personal property and giving constant threat to life are:
