I beg to report that today i.e. On 21-04-21 while performing special raid against illegal aicohol, at 18-20 hrs. I received a source information that one person namely- Kartick Das (55) yrs. S/O-Late Pran Bandhu Dasof Jyotinagar colony, Near 4th Mahananda bridge, Ward No-4, P.S.Siliguri, Dist. Darjeeling,, is selling huge alcohol in the house at Jyotinagar colony, Near Mahananda 4th Mahananda Bridge, Siliguri, SPC, of the accused person. P.S.Siliguri, Dist. Darjeeling without any valid license and documents in higher price than the actual value for his illegal gain. Accordingly I informed the fact to I/C. After reaching at Jyotimagar colony. Near Mahananda 4th bridge. Siliguri, SPC, at 18:45 hrs and as shown by the source. I found the above noted person is selling liquor and selling secretly in the house of the accused person at Jyotinagar colony, Near Mahananda 4th, Bridge, Siliguri, SPC, to different persons and seeing the Police party the above noted purson try to flee away but we managed to intercept him. On being asked he disclosed his identity as mentioned above. During search, I could recover the above noted alcohol kept its gunny bag. During interrogation he admitted that he is selling alcohol for his wrongful gain. On demand he failed to produce any valid license or documents in support of such business. During local enquiry it has been confirmed that the above noted person is selling alcohol illegally since long. Accordingly, I (i) 25, (Twenty Pive) bottles of Himalaya Gold 60 up Country spirit containing 600 ML in each bottle mentioning M.R.P of Rs 100/+ in .each bottle i.e. total amount of Rs-2500/- (Two thousand Five Hundred) in which 01 (one) bottle taken as sample and marked as Exhibit-"A-1" and (ii) 30, (Thirty) bottles of Himalaya Gold 60 up Country spirit containing 300 ML. in each bottle mentioning M.R.P of Rs-50/- in each bottle i.e. total amount of Rs-1500/- (one thousand Five Hundred) in which 01 (one) bottle taken as sample and marked as Exhibit-"B-1" The above noted recovered LD. liquors under proper seizure list duly packed, sealed and labeled in presence of witnesses and took their signature in the seizure list and labels and also arrested the above noted accused person U/S- 41 Cr.P.C under proper memo of arrest and observing all the formalities of arrest. The service search and setzure process completed in between 18.55 hrs to 19.35 hrs on 21-04-21
