Sir,

In producing herewith two (03) accused persons namely (i) Ismael Ansari (37), S/O- Safiulah Ansari of Rangpo Upper Bazar, PO+PS- Rangpo, Dist- East Sikkim, (ii) Madhab Bhujal (31), S/O- Padam Bahadur Bhujel of Lower Zitlang, PO+PS- Rangpo, Dist- East Sikkim and one (iii) accused lady named Jaya Shree Pradhan (30), D/O- Hari Bahadur Pradhan of House No- 553, Cheuribotey, PO- Duga, PS-seizure list;

- a) One transparent plastic packet containing thirty (30) grams of brown sugar kept concealed inside the tool box of a Maruti Alto vehicle having number plate- SK 01 T 7826 and marked as Exhibit- "A"
- b) One transparent pouch containing five (05) grams of brown sugar taken as sample from exhibit "A" for examination and marked as Exhibit "A-1".
- c) One Maruti Alto vehicle having number plate- SK 01 T 7826 and marked as exhibit "B".
- I, SI Md. Sanaullah, S/O- Md. Nurul Hoque of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against above noted (i) Ismael Ansari, (ii) Madhab Bhujel and (iii) Jaya Shree Pradhan to the effect that today on 24.04.2021 at about 15.25 hrs in Course of performing Mobile Van duty along with CV/154 Babu Sarkar and CV/783 Nirod Singha vide on Maruti Alto vehicle are waiting at By Pass More under PS- Matigara, Dist- Darjeeling with huge quantity of Brown Sugar for selling the same to their designed customers.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Accordingly, I along with force left for By Pass More, Matigara to verify the veracity of the above information. On way to By Pass More, I contacted two persons namely (i) Md. Khalilur Rahaman, S/O-Lt. Md. Hasan Ali of Tarijote, PS- Matigara, Dist- Darjeeling and (ii) Arun Roy, S/O- Mohit Roy of Hore krishna Pally, PS- Matigara, Dist- Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed.

At 15.45 hrs we reached at By Pass More under PS- Matigara, Dist- Darjeeling and subsequently, being pointed by my source detained above noted vehicle having number plate- SK 01 T 7826 at By Pass More, Matigara and found above noted Madhab Bhujel was on driving seat and Ismael Ansari and Jaya Shree Pradhan were found seating on the backside seat of the vehicle.

Thereafter, we disclosed our identity and the information in hand and stated them that they will be searched in person for the purpose. At this, they after disclosing their identity as noted above admitted that they have illegally possessed brown sugar in their possession for selling the same to their designed customers as per requirement. I then gave them option in writing whether they wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer. Then they agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused persons to search our Police Party as per provisions but, they did not search the police party.

Accordingly, I informed the matter to O/C Matigara PS and as per his kind order, I informed to Sri Narendra Kalicotay, Assistant Commissioner of Police, Siliguri Police Commissionerate acting as Special Executive Magistrate, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused persons suspected to be possessed Brown Sugar and requested him to come at By Pass More to remain present and to supervise the search and seizure. I also requested to O/C Matigara PS for sending lady officer/force and investigation kit for the purpose.

Accordingly at 16.15 hrs LC/1251 Yankila Bhutia of Matigara PS, SPC arrived at By Pass More, Matigara along with Investigation Kit. At 16:35 hrs Sri Narendra Kalicotay, Assistant Commissioner of Police, Siliguri Police Commissionerate arrived at the spot as Special Executive Magistrate, SPC and in presence of two independent witnesses search has been conducted of the detained persons/lady as well as their belongings following all formalities keeping their decency and recovered the above noted articles from the exclusive and conscious possession of accused Ismael Ansari, Madhab Bhujel and Jaya Shree Pradhan.

On demand, in presence of Sri Narendra Kalicotay, Assistant Commissioner of Police, Siliguri Police Commissionerate acting as Special Executive Magistrate, SPC the detained persons namely Ismael Ansari, Madhab Bhujel and Jaya Shree Pradhan failed to produce any valid document in support of possessing of the brown sugar.

Thereafter, I weighted the recovered packet with the weighing instrument and found thirty (30) grams of brown sugar kept in a transparent pouch which was found kept concealed inside the tool box of a Maruti Alto vehicle having number plate- SK 01 T 7826 and marked as Exhibit- "A".

Then, I seized the above noted articles at the spot under proper seizure list and also labeled and sealed all the articles in presence of Sri Narendra Kalicotay, Assistant Commissioner of Police, Siliguri Police Commissionerate acting as Special Executive Magistrate, SPC and independent witnesses and also obtained signature of the above noted witnesses and the Special Executive Magistrate, SPC and put my signature too and also acknowledged by the accused persons. The whole process of seizure was made in between 16.45 hrs to 17.25 hrs.

Being further asked the apprehend persons namely Ismael Ansari, Madhab Bhujel and Jaya Shree Pradhan admitted in presence of Sri Narendra Kalicotay, Assistant Commissioner of Police, Siliguri Police Commissionerate and other witnesses that they have procured the brown sugar clandestinely for the purpose of selling the same in high rate to their designed customer for their personal gain by illegal means. They also disclosed that they have been dealing in such business of procuring and selling of brown sugar illegally for last few months.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons namely Ismael Ansari, Madhab Bhujel and Jaya Shree Pradhan are involved in procuring and selling of brown sugar illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused persons/lady namely Ismael Ansari, Madhab Bhujel and Jaya Shree Pradhan after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely (i) Ismael Ansari (37), S/O- Safiulah Ansari of Rangpo Upper Bazar, PO+PS- Rangpo, Dist- East Sikkim, (ii) Madhab Bhujal (31), S/O- Padam Bahadur Bhujel of Lower Zitlang, PO+PS- Rangpo, Dist- East Sikkim and one (01) accused lady named Jaya Shree-Pradhan (30), D/O- Hari Bahadur Pradhan of House No- 553, Cheuribotey, PO- Duga, PS- Rangpo, Dist-East Sikkim (not verified) and arrange for its investigation.
