On being asked the above noted persons stated that they were well aware of pandemic Covid-19 situation and they supposed to wear face mask. Further I requested them to wear Mask and maintain the social distance but they did not pay any heed. Hence they all violated the order of Govt. of India duly promulgated in order no 40-3/2020-DM-1 (A), Govt. of India Ministry of Home Affairs Dated 24.03,2020.
