Sir,

With due respect and in producing herewith 05 (Five) persons namely (1) Md. Ismail (32), S/O. Md. Amin of Salbari, Nayabusty, PS – Pradhan Nagar, Dist. – Darjeeling, (2) Dama Ram Barail (66), S/O. Lt. Parsuram Barail of Salbari, Shibnagar, PS & Dist. – do, (3) Motilal Sahani (55), S/O. Madan Lal Sahani of Jhauguvi Busty, Khaprail, PS – Mtigara, Dist. – Darjeeling, (4) Nikhil Thapa (20), S/O. Mani Bdr. Thapa of Bloom Field, Dali, PS – Sadar, Dist. – Darjeeling and (5) Pankaj Kumar (22), S/O. Binod Kumar of Haspur Osti, PS. – Malma, Dist. – Baishali, Bihar who have been arrested by me of the following ground:

That sir, today on 28.04.2021 at about 10.45 hrs an information has been received by the on duty officer of Pradhan Nagar PS that, peoples are not following COVID-19 guidelines at Salbari Bazar which leads to spread of virus among the public in general. Accordingly, as per order of I/C Pradhan Nagar PS myself along with SI T.T. Bhutia, ASI Nilam Sarnakar, SI Chetan Dangal and force left PS vide PDN PS GDE No. 1463 dtd. 28.04.2021 to pursue the information. On reached at Salbari Bazar we found the above noted persons are roaming at the area without wearing mask, not maintaining social distance norms and splitting in the public place violating the Govt. Order No. 79-CS /2020 dtd 12.04.2021 of Gove of West Bengal and Home and Hill Affairs Department of the Govt of West Bengal, vide notification number 237-I S.s /2M-24/2020 dtd 03.06.2020 and Memo no. 486-CS /2021 dtd. 24th April, 2021 of Chief Secretary & Chairman, State Executive Committee WBSDMA. Accordingly, the above noted persons was detained on being interrogated disclosed their identity as above and further failed to give any satisfactory answer regarding their such activities in that area rather they refused to comply with direction of the Government regarding spreading of COVID-19. Hence, I arrested them u/s- 41 Cr.P.C, issuing copy of Memo of Arrest and informing the ground of their arrest.

Therefore, I pray before your good office that a specific case under proper section of Law may kindly be started against the above noted accused persons and arrange for its investigation.
