With due respect I Smt. Asha Devi, wife of Sri Jitan Sha of Babubasa, Champasari, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling hereby inform you that Dipak Gupta, S/O Sri Avdesh Gupta of Debidanga, Champasari, P.O. & P.S. Pradhan nagar, Dist. Darjeeling took loan from me the sum of Rs.50,000/(Rupees fifty thousand) only for since last 4 years ago and I paid him the amount by taking loan from Mahendra Finance. That said Dipak assured me to pay the same on 30-04-21. That on this day at about 5 to 5.30 PM said Dipak called me at Debidanga Hat, Champasari with an assurance to pay me the amount the sum of Rs.50,000/(Rupees fifty thousand) only. That when I along with my husband reached at Debidanga Hat, Champasari, P.S.Pradhan Nagar as per his assurance said Dipak Gupta his father gathered there and started assaulted me and by husband by bamboo and fist & blow and my husband and I sustained injuries. That said Dipak Gupta also tears my sari I wear that time and also issued slang languages towards me. That said Dipak Gupta and his father show odd gesture and posture and assaulted my modesty. That after the incident they also shouted that they shall do such thing again whenever they wish, I went to Siliguri District Hospital for my treatments. Sir the above named persons are dangerous in nature and they may do anything they want.

So, therefore I am requesting you kindly look into the matter and take appropriate legal action against said Dipak Gupta and his father Avdesh Gupta as yearly as per your convenient.
