In producing herewith one arrested accused person namely Rahul Shaw (28), S/O-Rajesh Shaw of 22/1, Dr. Suresh Sarkar Road, Antalli, P.S-. Antalli, Kolkata-700014, A/P- Shelcon Garden apartment, Debidanga, P.S.- Pradhan nagar, Dist- Darjeeling along with seized article viz; i) One iron made Pistol, having barrel length about 17cm (Approx) and butt length 11cm(Approx), ii) Two (02) nos Magazine case length 10cm (approx), iii) 11 round ammunitions marked as KF 7.65, (out of which 6 round was loaded in the above said pistol with in a magazine) and iv) One red colour Hyundai Creta Car bearing Reg. No. UP16BH-5906.

I beg to report that I SI Binup Mahato of Pradhannagar Police Station, SPC do hereby lodge this complainant against the above noted accused person to the effect that on 01.05.2021 around 20.35 hrs received a secret information from my reliable source that one person driving a red colour Creta car is coming from Debidanga towards Champasari bazaar and he has illegal arms in his possession. Immediately the matter was informed to you vide Pradhan Nagar P.S. GDE NO. 44 DTD. 01.05.2021 and under your kind direction myself accompanied with ASI Ratan Pradhan, ASI Debasish Das, ASI Ashit Singha, CV 131 Ranjan Sharma, CV 128 Ajay Kr. Sahani, CV/223 Swapan Chettri of Pradhannagar P.S. proceeded to work out the information vide PDN P.S.GDE No 45, Dtd 01.05.2021 And at about 20.45 hrs we arrived at the said place and again contacted with my source and on being indicated the car and identified by him, I along with my police party stopped the Hyundai Creta car bearing Reg. No. UP16BH-5906 and apprehended the above noted person at Champasari More, under Pradhannagar P.S. We gave our identity and also disclosed the information in hand in presence local witnesses. On asking he gave his identity as noted above. On being searched the car I recovered i) One iron made Pistol, having barrel length about 17cm (Approx) and butt length 11cm(Approx), ii) Two (02) nos Magazine case length 10cm (approx) & iii) 11 round ammunitions (out of which 6 round was loaded in the above said pistol with a magazine and another 5 round was loaded in another magazine) found in the left side dash board of the said car. On interrogation the accused person made incoherent statement regarding possession of the Pistol and failed to produce any valid license for possessing the said arms. Accordingly, I seized the aforesaid articles, under proper seizure list. (Seizure was made in between 20.50 hrs and 21.05 hrs) duly signed by the accused person as well as witnesses in the seizure list and arrested the accused person for violation of the provisions of Arms

On the above circumstances, I pray that a specific case under proper section of law may kindly be started against accused person Rahul Shaw (28), S/O-Rajesh Shaw of 22/1, Dr. Suresh Sarkar Road, Antalli, P.S-.
