In the month of July 2020 I came in touch with two persons namely Braj Lal Yadav (7679153078) S/O R.K Yadav of Devidanga main road, near petrol pump, P.S. Pradhan nagar & Babu Nanda Mishra (9832423631/7679147758) Son Of Late Daroga Mishra of ward no. 42 of S.M.C, Salugara, P.S. Bhaktinagar. They assured me and offered me to become partners of above mentioned nursing home and promised me to fulfil the other legal liability and financial liabilities and also to fulfil financial dues of the other Partners. They also promised me to maintain financial interest of all the partners but they did not fulfil any requirements. They

manipulate all accounts details and produce false statements. They grabbed more than 20 lacs, rupees by fraud from the above mentioned nursing Home, They in last 10 days misappropriate 20 Lacs rupees for their personal gain by taking me in confidence, they induced me to come into a new partnership with them. Through this way they cheated with me and breached my trust. They promised me to pay all the dues and share of the other partners which now they denied to give it

By doing this they are cheating with the patients, government and society at large by taking in appropriate money. As the License of the said nursing home is in my name I do not want to involve them into day to day operation any more.

I hereby request you to look into this matter and investigate the matter and take action against these tricksters in accordance with law.
