Sir,

In producing herewith 05 (Five) arrested accused persons who disclosed their identity as (i) Bubai Jana-32yrs s/o Ganesh Jana of Hayed Nagar PS- Falta Dist South 24 Pargana (ii) Dipen Pradhan-37yrs s/o Moni Kumar Pradhan of Upper Ramatay, PS Sonada Dist Darjeeling (iii) Subham Kumar Das-22yrs s/o Umesh Kumar Das of Ganganagar, PS Siliguri Dist Darjeeling at Present Kholaboktari PS Matigara Dist Darjeeling (iv) Md Azad-32yrs s/o Md Kalu of Dangipara near Rajendra Prasad High School, ward no-VI, PS Siliguri Dist Darjeeling and (v) Narayan Roy-32yrs s/o Ajay Roy of Nawapara, Sahudangi, PS NJP Dist Jalpaiguri along with seizure list and seize articles. The seizure articles viz:-

1. One TVS Apache having Registration no-WB74AQ/8629

I, SI. Upendra Nath Roy of Khalpara TOP under Siliguri PS, SPC do hereby lodge complaint against the above noted arrested persons, to the effect that while on 25.04.21 at 11.45 hrs performing Special mobile van duty myself along with officer and force had been to Gandhi Maidan, Khalpara, Siliguri vide Khalpara TOP GDE No-1106 dated 25.04.21 and found that the above noted persons along with vehicle had made unnecessary gathering at the public places without wearing mask. On being asked the above noted persons stated that they were well aware of the COVID-19 pandemic situation and disobeyed the Govt guidelines without any valid reason.

Hence all of them violated the order of Govt. of West Bengal duly promulgated and circulated by Civil and Police authorities in order no -486-CS/2021 dated 24.04.21 arising out of order No- 79-CS/2020 dated 12.04.2020, **wearing of facial mask has been made mandatory in public places in the current pandemic disaster situation** and to prevent spread of COVID-19 .. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view to stop the break-out of Pandemic COVID- 19 throughout the Country. Accordingly I arrested them after issuing proper arrest memo and maintaining health protocols ensure their safety and security.

So, I therefore request you for starting a specific case under proper section of law against the above noted arrested accused persons and arranged proper investigation of the case.
