like to inform you that some people in our locality in  
railway track they are taking some kind of drugs, and  
drinking namely <sup>①</sup> Sudhin Mahato <sup>②</sup> Anirath Rai <sup>③</sup> Ahimad  
Ali s/o - Asgar Ali <sup>④</sup> Asgar Ali. They are all are R/o - Adarsho  
Nagar. Ward No:- 4 P.S. Siliguri. Dist. Darjeeling. When we tried

to stop them for not doing this type of drinking and taking  
drugs injection in our locality at that time they started  
fighting with us and started pelting stone in us above  
noted person, and started to use strong languages  
in respect of me as well as in respect of other person  
mentioned above. When we tried to protest the

same at that time he called his other associates.

After that of all of them without any reason they started  
to assault me by using Railway Track Stone at us  
and with dath and Bamboo at that time after  
listening our hue and cry my friend came to the

my spot at that time the above noted persons intentionally used vajali and tried to kill me and after assaulted by them one of my us get injured namely Bi joy Kumar Prasad. Became senseless and also sustained multiple injuries on my whole body specially in my head but due to mercy of god or my friends some how they rescue me from their hand and immediately took me to Siliguri District Hospital and attending Doctor advise me for stitch and it is also important to mention that ~~after~~ when I was in hospital at that time above noted persons came into my home and broke all the necessary items like t.v, table, window, etc and after that above noted person also threatened me with dire consequences and told me that if I intruded the aforesaid fact to any authority then they will kill me on road so, right now I spend my <sup>whole</sup> day very bad condition and at that time of said incident the above noted person intentionally took a sum of Rs. 3,000/- (Rupees Three thousand) only from my chest pocket and also they destroy my home. So, no other alternative way today with the help of my well wishers I lodged this @ written complaint before you.

Therefore I request you be pleased to draw your kind attention in respect of my above noted written complaint and take necessary step against the above noted persons as early as possible.
