I Sri. Sourav Sarkar, S/o- Sri Sudip Sarkar residing at Saradapally, Siliguri, P.O. Rabindra Sarani, P.S. Bhakti Nagar, Dist. Jalpaiguri is a General Secretary of Bharatiya Janata Yuva Morcha, Siliguri Dist. (org.) Committee do hereby beg to state that yesterday night i.e. on 02.05.2021 at about 10:30 PM when I was standing in Raja Ram Mohan Roy Road and Haren Mukherjee Road Crossing, Hakimpara for availing a Toto or rikshaw to go home 1) Pritam Ghosh @Baban, who happens to be General Secretary at Siliguri College of TMCP Unit, 2) Rudra Sarkar, Vice-President Siliguri College TMCP Unit both residents of Balai Das Chetarjee Road, Near Aikkya Sammilani, Ward No. 16 of SMC, Siliguri, 3) Alik Roy of Rabindra Nagar Main Road, Ward No. 38 of SMC, Siliguri along with 15 to 20 unknown miscreants all antisocial in nature, caught hold of me and started assaulting me very brutally with fists and blows without giving me a reasonable chance of saving myself. They addressed to me with dirty and filthy words and threaten to kill me if I continue to work as a BJP kariyakarta. All of them continued assaulting me from all the sides until I succumbed to their attack and fell down on the ground half conscious.

It is pertinent to mention here that since few days I was being threatened over telephone being No 8597348627, 7430061064 that I shall be killed if I do not leave working in BJP. I have recoded the said conversation and shall be provided whenever needed.

Apprehending threat to life and liberty, I request you to immediately investigate into the same and start criminal proceedings against the wrong doers under appropriate provisions of law and put them behind the bars.
